### AN ACT TO AMEND § 3606(d)(4) OF CHAPTER 3, TITLE 16 AND § 51202 (c) OF ARTICLE 2, CHAPTER 51, TITLE 10, GUAM CODE ANNOTATED AND TO ADD A NEW ARTICLE 6 TO CHAPTER 51 OF TITLE 10 GUAM CODE ANNOTATED RELATIVE TO THE DISPOSAL OF JUNK VEHICLES.

#### **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds that 3 the scope of Guam's abandoned vehicle is broad since it encompasses all vehicle 4 types including those that park unlawfully, those impounded for any reason and 5 those left to rot on public property.

*I Liheslaturan Guåhan* finds that throughout all jurisdictions in the United
States, disposing of junk vehicles in woods, ponds or deserts is a littering violation
and violators, if found, are penalized accordingly. Unfortunately, Guam appears to
have a much more severe junk vehicle littering problem than the rest of the nation
and the current vehicle transfer laws make it difficult to identify the lawful owners.

It is the intent of *I Liheslaturan Guåhan* to add junk vehicles to the definition of littering, to provide procedural due process in the form of a 48-hour notice and direct the fines and fees in existing law to the recycling revolving fund. It is further the intent *I Liheslaturan Guåhan* to allow the current solid waste management, environmental protection and public roadway laws remain the basis for the proper
 disposal/ recycling of junk vehicles.

3 Section 2. § 3606(d)(4) of Article 6, Chapter 3, Title 16, Guam Code
4 Annotated is hereby *amended* to read as follows:

5 "(4) The proceeds of each sale shall be deposited in the Abandoned Vehicle 6 and Streetlight <u>Recycling Revolving</u> Fund. Five percent (5.0%) of all 7 proceeds collected or received under this Section shall be deposited into the 8 Recycling Revolving Fund and is hereby appropriated and shall continue to 9 be deemed appropriated to the Guam Environmental Protection Agency to be 10 expended on administrative costs."

- Section 3. § 51202 (c) of Article 2, Chapter 51, Title 10, Guam Code
  Annotated is *amended* to read as follows:
- (c) Litter shall mean discarded, used or leftover solid materials, including, but
  not limited to, garbage, trash, rubbish, refuse, paper, containers, bulky metallic
  waste, packing or construction materials, or carcasses of dead animals, or junk
  vehicles as defined under 10 GCA § 516101.

17 Section 4. A new Article 6 is hereby added to Chapter 51, Title 10 Guam Code18 Annotated to read as follows:

<u>"Article 6</u> 19 **Junk Vehicles** 20 § 516101. Definitions. For purposes of this article 21 (a) "Automotive scrap metal" means the parts of an automobile made of iron 22 or alloys of iron and *non-ferrous metals* as defined by 11 GCA § 74101(d). 23 (b)"Depollution" means the first step in vehicle recycling, and it focuses on 24 removal of batteries and all the fluids that are used in the operation of a 25 26 motor vehicle, including, but not limited to: gasoline, diesel fuel, oil,

| 1  | coolant, brake fluid, transmission fluid, air conditioning refrigerant, gear |

| 2  | oil, and windshield washer fluid. These materials, once removed from the     |

| 18 | (g) "Transportation and Disposal Cost" means the cost to tow a junk vehicle  |
| 19 | to a scrap dealer, salvage yard, or a recycling center for depollution and   |
| 20 | proper disposal and the cost to ship the junk vehicle away from Guam.        |
| 21 | <u>§ 516102. Junk Vehicle Forfeiture of Title.</u>                           |
| 22 | (a) An owner of a junk vehicle is deemed to have intentionally relinquished  |
| 23 | title to their junk vehicle when:  |
| 24 | (1) A littering violation is issued under Article 2 of this Chapter,         |
| 25 | involving said junk vehicle; and   |

| 8  | Protection Agency, Mayors or their designees, may post a "Notice of Relinquishing   |
| 9  | of Title" (Notice) on any junk vehicle found on public property.                    |
| 10 | (b) The Notice shall be approved as to form by the Attorney General of Guam         |
| 11 | within Ninety (90) days of the enactment of this section.                           |
| 12 | (c) Notices shall be recorded at the Motor Vehicle Division of the Department       |
| 13 | of Revenue and Taxation (DRT) and with the mayoral office of the village where      |
| 14 | the vehicle is located.   |
| 15 | (d) No Notice shall be posted on a junk vehicle unless and until the Guam           |
| 16 | Environmental Protection Agency certifies that: (1) funds are available to pay for  |
