***AN ACT TO ADD NEW SECTION §855 TO TITLE 1 GUAM
CODE ANNOTATED TO DESIGNATE ROUTE 3 AS “BEN
BLAZ BLVD.”***

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds that the Marine Base Camp Blaz, which was activated October 1, 2020, was named in honor of Brigadier General Vicente Blaz, USMC. General Blaz is the first Chamorro to achieve flag rank in the armed forces of the United States. General Blaz retired in 1980 and returned home to Guam. General Blaz was elected as our Delegate to Congress in 1984 and was a strong advocate for the political advancement of Guam and the Marianas.

It is the intent of *I Liheslaturan Guåhan* to recognize the career of General Vicente Blaz, known far and wide as Ben Blaz, by naming Route 3 consistently with Route 3's connection to Camp Blaz and Marine Corps Drive.

Section 2. A new §855 is *added* to Chapter, Title 1, Guam Code Annotated to read as follows:

§855. Designating Route 3 as “BEN BLAZ BLVD.”

1 Route 3 is designated as “BEN BLAZ BLVD.” The Director of the
2 Department of Public Works shall post signs visible along Route 3 that displays the
3 name of the highway and dedicates the highway to honor the distinguished service
4 first son of Guam to attain a flag officer rank in any of the branches of the armed
5 forces of the United States. The Director of the Department of Public Works shall
6 further cause to be affixed prominently and in overhead display, such signs at the
7 intersections of Route 1 and Route 3, and the junction of Route 3A, Route 9 and
8 Route 3; and shall clearly designate Route 3 as “BEN BLAZ BLVD.”
