AN ACT TO TEMPORARILY WAIVE THE PAYMENT OF BUSINESS LICENSE FEES FROM OCTOBER 1, 2020 TO SEPTEMBER 30, 2022, AND TO ALLOW FOR A BUSINESS LICENSE FEE CREDIT FOR BUSINESSES WHO PAID THEIR LICENSE FEES PRIOR TO THE ENACTMENT OF THIS ACT; AND TO CITE THIS ACT AS THE “*BUSINESS ASSISTANCE ACT OF 2021.*”

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Short Title.** This Act shall be cited as the “*Business Assistance*
3 *Act of 2021.*”

4 **Section 2. Waiver of Business License Fees.** Notwithstanding any
5 provision of law, or rule or regulation, all business license fees, including, but not
6 limited to, fees for business license renewal that are due from October 1, 2020 to

7 September 30, 2022 shall be waived without penalty to the license holder. Any
8 license fees collected between October 1, 2020 and September 30, 2022 shall be
9 credited to any fees owed by the license holder after the period waived by this
10 provision.

11 **Section 3. Effective Date.** This Act shall be effective upon enactment.
