## AN ACT TO AMEND § 75A124 OF CHAPTER 75A, TITLE 21, GUAM CODE ANNOTATED, RELATIVE TO THE CHAMORRO LAND TRUST SURVEY AND INFRASTRUCTURE FUND.

1	BE IT ENACTED BY THE PEOPLE OF GUAM:
2	Section 1. § 75A124 of Chapter 75A, Title 21, Guam Code Annotated, is
3	hereby amended to read:
4	"§ 75A124. The Chamorro Land Trust Survey and Infrastructure
5	Fund.
6	The Chamorro Land Trust Commission shall create a special fund
7	called the Chamorro Land Trust Survey and Infrastructure Fund (Fund),

1 which shall be maintained separate and apart from any other funds and shall 2 not be subject to the transfer authority of I Maga'låhen Guåhan. Notwithstanding any other provision requiring the deposit 3 (a) of proceeds to other funds, the Fund shall receive: 4 5 the proceeds of all sales of bull cart trails, substandard lots, (1)6 irregular lots, remnants, splinter lots, fractional lots, easement purchase 7 remnants, and easement condemnation remnants belonging to the 8 government of Guam; 9 the proceeds of CLTC commercial leases or licenses (2)10 executed after October 2015; and the proceeds of CLTC commercial submerged lands 11 (3) 12 license agreements, to include license fees, landing fees, fines, and 13 interest. Expenditures from the Fund shall be made pursuant to a 14 (b) 15 resolution by the CLTC, and shall be restricted to the following expenditures: 16 (1)for the subdivision, surveying, mapping and registration of 17 tracts of residential and agricultural land in the CLTC property 18 inventory; and (2)for the construction of infrastructure, to include access 19 20 roads, water, sewer, power utilities, telecommunications resources, and 21 subdivision improvements, which include, but are not limited to, storm 22 drainage facilities, curbs, street gutters, and sidewalks, to service CLTC residential and agricultural tracts of land. 23 24 (c)The Commission shall report on a quarterly basis to the Speaker 25 of *I Liheslaturan Guåhan* as to the revenues collected and expended from the 26 Fund, and post the same on the website of the Chamorro Land Trust 27 Commission. The Fund shall be subject to audit by the Guam Public Auditor."

Section 2. Effective Date. This Act shall be effective upon enactment.
Section 3. Severability. If any provision of this Act or its application to any
person or circumstance is found to be invalid or contrary to law, such invalidity shall
not affect other provisions or applications of this Act that can be given effect without
the invalid provision or application, and to this end the provisions of this Act are
severable.
