





**AN ACT TO AUTHORIZE THE EXTENSION OF THE
GAS TAX RELIEF ACT FOR ANOTHER ONE HUNDRED
EIGHTY (180) CALENDAR DAYS; AND TO
APPROPRIATE FIVE MILLION TWO HUNDRED
FIFTEEN THOUSAND EIGHT HUNDRED TWENTY-
THREE DOLLARS (\$5,215,823) TO THE GUAM
HIGHWAY FUND FROM FISCAL YEAR 2022 GENERAL
FUND REVENUES COLLECTED IN EXCESS OF
ADOPTED LEVELS TO COVER THE FINANCIAL
IMPACTS OF THE GAS TAX RELIEF ACT.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Authorization to Extend the Gas Tax Relief Act.** All levy of
3 excise taxes, automotive surcharges, and mass transit automotive surcharges on

1 liquid fuel shall be temporarily waived for another one hundred eighty (180)
2 calendar days.

3 **Section 2. Appropriation.** The amount of Five Million Two Hundred
4 Fifteen Thousand Eight Hundred Twenty-three Dollars (**\$5,215,823**) is hereby
5 appropriated to the Guam Highway Fund from Fiscal Year 2022 General Fund
6 revenues collected in excess of adopted levels.

7 **Section 3. Effective Date.** This Act shall be effective upon enactment.

8 **Section 4. Severability.** If any provision of this Act or its application to any
9 person or circumstance is found to be invalid or inorganic, such invalidity shall not
10 affect other provisions or applications of this Act that can be given effect without
11 the invalid provision or application, and to this end the provisions of this Act are
12 severable.
