I'd like to thank Senator Mary Torres for hosting this hearing for me as well as my seven colleagues who signed on to this resolution with us.

A few months ago, we empaneled legal scholars, government representatives, and community stakeholders to discuss the impact of federal policies and how it has disenfranchised not only the People of Guam but nearly four million Americans across the territories. I also had the honor of testifying in front of the House Committee on Natural Resources to advocate for Guam's inclusion in crucial federal programs such as SSI and parity when it comes to the applicability of Medicaid to Guam.

Together, Senator Torres and I continued to advocate for the inclusion of Guam in federal programs such as Social Security Income. We wrote countless letters to Chairman Grijalva, Vice Chair Killili Sablan, and Congressional Leadership. We engaged with the White House. And we reminded them that they did not have to wait for the courts to finally address the injustices of the past—it had the power to do so right now. I repeatedly requested that Congress, under its Plenary Powers, pass legislation that would create equity among states AND territories as it relates to the application of federal programs.

Congress has finally heeded to our call.

The Biden Build Back Better Framework will extend SSI benefits to Guam and increase Medicaid Funding for Guam, effectively averting the Medicaid Cliff. It will also provide access to childcare, free preschool, make higher education more affordable, provide training opportunities for our People to obtain high-paying jobs, reduce the cost of housing, and cut taxes for many of our hard-working families.

Buenas Yan Hafa Adai Committee Members. My name is Anthony M. Babauta and I am both honored and pleased to join you this morning as the Committee receives testimony on Resolution 203-36 which, if passed, would express the Guam Legislature's endorsement of the Build Back Better Act, which as you know is a key legislative initiative of President Joe Biden. I appear in my capacity as Chairman of the Democratic Party of Guam, and offer our resolute support in favor of this Resolution's passage.

We would like to thank the Resolution's main sponsor, Vice Speaker Tina Muña Barnes, for her leadership on this issue and her consistent engagement with the U.S. Congress and the Executive Branch on a multitude of issues that define Guam's relationship with the federal government.

We want to thank the Vice Speaker's democratic colleagues, Speaker Terlaje and Senators Nelson, Shelton, San Augustin, and Pedo Terlaje for their co-sponsorship. Equally, the Democratic Party expresses its gratitude to minority Senators Camacho Torres, Moylan and Ada, for adding their support to this measure which makes this effort a truly bipartisan endeavor.

President Biden's Build Back Better Act proposes a once-in-a-lifetime investment for Guam, as well as our sister U.S. territories and States in our Union. If passed by the U.S. Congress, Build Back Better will create new jobs at higher wages, open the doors to join the workforce, spur long term economic growth, and reduce the cost of living for the one hundred sixty thousand residents who have made Guam their home. The Act also provides opportunities for our island to live a cleaner, more sustainable lifestyle, and ultimately ensure that we can do our part to combat climate change and rising sea levels.

For many reasons, Guam's cost of living is high and getting ends to meet in many households can be a month-to-month and paycheck-to-paycheck challenge. For many households with children, whether traditional or single parents, making ends meet means taking on a second or even a third Anthony M. job. Studies show that when a parent has to work more than one job, it could negatively impact the livelihoods and futures of their child. Data has further shown that 1 in 10 Asian American and Pacific Islander parents have had to quit, turn down, or make changes to their jobs due to disruptions to their childcare. President Biden's Build Back Better Plan will ease the burden on families with investments that, if enacted, would save families thousands of dollars in childcare and preschool costs and build a strong, stable early learning system that meets the needs of families, providers, and the economy.

Guam's housing costs have risen to where homeownership for most residents seems unreachable. Many factors of course affect the cost of homes, and apart from construction costs one of them is supply. President Biden's Build Back Better Plan will address the supply issue by enabling the construction, rehabilitation, and improvement of more than 1 million homes. This would increase the supply of housing and drive prices down. Because homeownership is a path to building wealth and a stronger middle class, we need to be extra vigilant of this program and how we get resources to build more affordable homes for our people.

I'm a strong proponent of taking advantage of federal opportunities, so it's gratifying to know that on this housing issue, Vice Speaker Barnes and Senators San Augustin, Shelton, Nelson, Pedo Terlaje, and Mary Camacho Torres, have been working with the Leon Guerrero-Tenorio Administration to proactively engage the Department of Housing and Urban Development seeking federally designated revitalization areas on Guam. It is my understanding that based on your efforts, data has been compiled and submitted to HUD and soon our island will learn of the success of your effort.

Former President Trump's initiative, the Tax Cuts and Jobs Act of 2017, which remains the law of the land, made permanent corporate tax cuts and by and large, has been criticized for increasing the national debt, creating greater income inequality, decreased healthcare coverage while increasing its cost, and created disproportionate impacts on States and territories. In response, as we know, former Governor Calvo signed into law a local measure increasing the island's Business Privilege Tax and additional 1% - where it remains today. Build Back Better proposes to fund itself by not allowing large corporations to zero out their taxes and not adding additional taxes to anyone making below \$400,000.

More importantly, it will continue providing opportunity for the middle class and for Guam, the President's Plan will extend Child Tax Credit (CTC) increases of \$300/month per child under 6 or \$250/month per child ages 6 to 17. The framework will also provide a tax cut of up to \$1,500 in tax cuts for low-wage workers in Guam by extending the American Rescue Plan's Earned Income Tax Credit (EITC) expansion.

To keep higher education within reach for our young adults, Build Back Better will increase Pell grants for nearly three thousand students on Guam who currently benefit from it. It is our hope that with this added relief, we can find ways to unlock further access to education beyond high school for all of our graduating students.

From my perspective of working on Capitol Hill, the Obama Administration, and Governor Leon Guerrero's chief of staff, I understand the many years of work that went towards telling Guam's story as it relates to Guam and her sister territories treatment under the federal program of Medicaid - which was always underfunded and unfairly applied - and Supplemental Security Income (SSI), which among the territories was only accessible to the Northern Mariana Islands. Governors and Delegates, both past and present - from all our territories, no matter the political party, have fought to increase Medicaid allotments and the federal match, which was first enacted under Obamacare. And subsequently, those increased benefits needed to be defended and extended since.

Similarly, extending the federal benefits to aged, blind, and disabled adults and children under the SSI program to U.S. citizens in U.S. territories is long overdue. President Biden's plan takes the historical step of making federal dollars available for some of our most challenged residents and allowing those families who had no other choice but to move away from Guam for SSI - return home and be surrounded by loved ones.

The President's plan also walks back every territory from the Medicaid cliff - and provides Guam \$140 million while reducing our matching requirement. This will expand healthcare access to our residents and unburden our local dollars so that we can make investments elsewhere for the benefit of our progress.

Again, these two issues have been championed by our elected leaders for decades and the story has been repeated year after year and the argument made from Administration to Administration. If passed, we thank all elected leaders from years past to the present, no matter the party. And we should remember our past leaders because they championed the cause term after term.

And for those in office today, to include Members of this body, we thank you for seizing the opportunity that President Biden's Build Back Better plan holds for the country and, most especially our island. This is truly a once-in-a-lifetime opportunity for the country and our island to Build Back Better.

Finally, I encourage the Committee to amend the Resolution's final Resolved clause, to include minority leaders from both the U.S. House and Senate. The Democratic Party of Guam recognizes that your effort is bipartisan and national leaders from the Republican Party should know that Guam's elected Republicans are unequivocally in favor of Build Back Better's enactment before the end of this year. We look forward to the Committee moving forward with this measure and for its final approval by the entire body.

WHEREAS, on October 28, 2021, President Joe Biden announced the framework of the Build Back Better Act to ultimately create millions of good-paying jobs, enable more Americans to join and remain in the labor force, spur long-term growth, reduce price pressures and set the United States on course to meet its clean energy ambitions. After months of long negotiations, a compromise had been reached with Democratic lawmakers. While much of the original plan remains intact,

the new \$1.75 trillion framework highlights climate change proposals and the expansion of Medicare benefits and inclusion of Americans living in territories with Supplemental Security Income; and

WHEREAS, the framework contains the largest effort to combat the threat of climate change by delivering substantial consumer rebates and tax credits to reduce costs for middle class families who have shifted to clean energy, ensuring clean energy technology, advancing environmental justice through a new Clean Energy and Sustainability Accelerator, and bolstering resilience and natural solutions to climate change; and

WHEREAS, with our island especially vulnerable to rising sea level, rising temperature, and an increase in tropical storms, the Build Back Better framework will empower the people of Guam to take action, build clean infrastructure, invest in innovative green technology, and protect our land and water resources; and

WHEREAS, the framework proposes a transformative investment in childcare and caregiving by offering universal and free preschool for all three (3) to four (4) year-olds as well as providing up to three thousand six hundred dollars (\$3,600) in tax cuts per child by extending the American Rescue Plan's expanded Child Tax Credit. This relief will allow families in Guam to plan for their future and make financial decisions to benefit their household; and

WHEREAS, the framework will provide for the basic needs of young students on Guam, addressing food insecurity and food deserts in our community. 30,000 students on Guam, many of whom unsure of when they will have their next meal over the summer, will be provided with access to nutritious food options; and

WHEREAS, the framework includes a significant effort to bring down costs and strengthen the middle class by making the largest and most comprehensive investment in affordable housing; extending the expanded Earned Income Tax Credit (EITC) for low-waged workers; expanding access to affordable, high-quality

education; promoting nutrition security for children's health, strengthening the middle class through historic investment in equity, safety, and fairness; and investing in immigration reform; and

WHEREAS, with 30% of household income on Guam going towards rent, the Build Back Better framework provides rental assistance for Guam renters, many of whom unable to attain a home of their own. Moreover, the plan will expand housing options providing investments in the U.S. public housing stock. Additionally, the framework will address down payment assistance and allow more first-generation homebuyers to finally purchase their own home; and

WHEREAS, the Build Back Better framework will provide more opportunities for Guam's young adults through training and education to better equip them for future industries and create a well-educated workforce. Additionally, for the 2,600 young adults who rely on Pell Grant awards the maximum award amount will be increased by \$550 for students. This will allow our young adults to prioritize their education and focus on their studies; and

WHEREAS, the framework offers the biggest expansion in health care and caregiving for our island's Manåmko' (elderly), the indigent, and individuals with disabilities; and

WHEREAS, The Build Back Better framework will improve access to healthcare for approximately 33,000 residents who are currently enrolled in Medicaid and improve Medicaid reimbursement at Guam Memorial Hospital, the island's public hospital. The plan increases federal Medicaid allotment funding for Guam to \$140 Million and the federal Medicaid match to 83%; and

WHEREAS, in prior fiscal years, Guam's Medicaid funding was capped at \$20 million a year with the Federal Medical Assistance Percentage for Guam typical held at a 55% federal Medicaid match. This change will expand Medicaid, especially for the working middle class on Guam; and

WHEREAS, the Build Back Better frameworks moves towards equity and parity among American citizens living in the territories based off of the decisions from U.S. v. Vaello-Madero, 956 F.3d 12 (1st Cir. Apr. 10, 2020) and Schaller v. U.S. Social Security Admin., et.al., No. 18-cv-00044)(D. Guam Jun. 19, 2020); and WHEREAS, the Build Back Better framework will extend Supplemental Security Income to low-income senior citizens and disabled citizens residing in Guam as well as the other territories, who have previously been unconstitutionally denied Supplemental Security Income; and

WHEREAS, the Build Back Better framework provides our community with needed resources and investment to stimulate and grow our economy and provide for the well-being of the people of Guam; now therefore, be it

RESOLVED, that the Committee on Rules of *I Mina'trentai Sais Na Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guahan* and the people of Guam, express the support of *I Mina'trentai Sais Na Liheslaturan Guahan* (the 36th Guam Legislature) for the passage Build Back Better Framework, which would provide needed investments in the community of Guam including parity for U.S. Citizens residing in the territories through Supplemental Security Income inclusion and expansion of Medicaid; and be it further

RESOLVED, that the Speaker and the Chairperson of the Committee on

Rules certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of the same be thereafter transmitted to the Honorable Joe Biden, President of the United States of America; the Honorable Kamala Harris, Vice President of the United States of America, President of the Senate; to the Honorable Patrick J.
