My name is Elizabeth Santos, Acting Executive Director of the Guam Election Commission (GEC) in the absence of Maria Pangelinan, who sends her apologies for not being here this morning. Si Yu'os ma'åse' for the opportunity to appear before you on Bill nos. 173-36 and 174-36. The GEC is mandated by 3 G.C.A. § 2103(d) to submit "recommendations of the Commission as to amendments or supplementation of laws affecting elections or the office of the Commission." The GEC appreciates that the proposed legislation incorporates many of the amendments recommended by the GEC submitted earlier this year. These recommendations are rooted in the GEC's commitment to conduct fair, honest, and open elections most effectively and efficiently possible.

Bill No. 173-36

Section 1. Cancellation of the Primary Election for Certain Circumstances. The GEC does not take a position with this proposed section. However, the GEC provides the following:

 To make Section 1 abundantly clear, the GEC requests an amendment to the language to read:

In any given election year, the Guam Election Commission shall cancel the Primary Election if equal to or fewer than the maximum number of candidates can advance to the General Election for any partisan elected office.

• GEC requests that the legislation also addresses the issue of independent candidates. Section 15207 provides that independent candidates may file nomination papers for the Primary Election. Then in Section 15404, independent candidates must meet certain thresholds to move on to the General Election. The issue then becomes for the GEC, do all independent candidates go through to the General Election if the GEC does not conduct a Primary Election for the partisan elected offices. The GEC requests that the proposed legislation address this issue to ensure that all potential candidates have the opportunity to seek elected office regardless of party affiliation.

• The GEC further recommends that the legislation include cancellation of the Primary Election for the nonpartisan offices. Currently, the Office of Public Accountability and Attorney General statutes require a primary election for the Public Auditor (1 G.C.A. § 1903(e)) and Attorney General (5 G.C.A. § 30101(b)). Requiring a primary election for the two nonpartisan offices increases election costs substantially because of the cost of printing a separate nonpartisan ballot and the amount of time it takes to tabulate the separate ballots.

Section 2. Amend Section 11115. Write-In Votes. The GEC supports Section 2 regarding not having to publish the name of the write-ins if the total votes for the write-in candidates do not change the vote tabulations for the named candidates. Removing the publication requirement simplifies GEC processes and eliminates unnecessary costs. Currently, GEC spends a significant amount of time sorting, reviewing, and tallying write-in votes to publish names such as Mickey Mouse and Superman. The proposed amendment requires the GEC to report the total number of write-in votes tabulated but only requires publication of write-in names if the number of write-in votes affects the outcome of any race.

• The GEC proposes the language to read:

The GEC shall count a write-in vote only if the write-in voting oval provided is marked and the elector provides a name written alongside the voting oval. The GEC shall report the results of the total write-in votes for each elected office. However, the GEC shall only publish the tabulation results for each of the named write-in candidates for that elected office if any write-in candidate receives enough votes to affect the ranking of any qualified candidate for a specific elected office.

Section 3. <u>Amends Section 9112. Electioneering at Polling Place Prohibited</u>. The GEC supports Section 3.

• However, the GEC proposes the language to read:

No person shall do any electioneering on election day within one hundred (100) feet of any entrance or exit of any polling place. The entrance or exit is defined as the entrance or exit gate if the polling place is fenced. The Commission may, on a case-by-case basis and limited to the current election, make an exception to this Section through a Commission Resolution if the GEC deems there to be a safety issue when conducting the election. The GEC has sole discretion and responsibility to determine and mark the one hundred (100) feet or other boundaries under this Section. Notices identifying the newly set perimeter also shall be posted at the entrance and exit of the polling place(s) affected. In addition, the GEC or any election official present at the polling place may seek

> the assistance of any law enforcement officer to promptly assist in the enforcement of this Section, including but not limited to removing any person from the polling place.

Section 4. Amends Section 1117. Definitions: District. The GEC supports Section 4 because it clarifies and makes the definition of "district" consistent with another provision of Guam law, specifically 1 G.C.A. § 403.

Section 5. Adds Section 1124. Definitions: Name. The GEC supports Section 5 because it explicitly defines the name for which a candidate must identify on all GEC nominating papers. However, this does not prohibit using a nickname or any other names a candidate may choose to place on the ballot pursuant to 3 G.C.A. § 7115.

Section 6. Amends Section 14105. Disposition. The GEC supports Section 6 because it simplifies GEC's processes by allowing the GEC to count provisional ballots simultaneously with the absentee ballots. Currently, § 14105(a) requires the GEC to count provisional ballots within ten days after an election.

In contrast, § 10114 requires that the GEC accept off-island absentee ballots until the tenth day after any election. Thus, these two statutes require the GEC to count provisional ballots and absentee ballots on two separate days. The proposed amendment to § 14105(a) would allow the GEC to simultaneously count provisional ballots and off-island absentee ballots, thus streamlining the ballot tablulating processes.

Amendments to § 14105(c) and (d) further clarify that all provisional voters meet the voter registration requirements of §§ 3102 and 14104(j) of the election law before the GEC could register provisional voters and use provisional ballot affidavits to remedy incomplete or otherwise deficient voter registration applications.

Section 7. Amends Section 13103. Election to Fill Vacancy in I Liheslaturan Guahan or the Seat of Washington Delegate. The GEC supports the intent of Section 7 with reservations. The amendment seeks to provide a mechanism to fill a vacancy in the Seat of the Washington Representative. The Organic Act states, "[i]n case of a permanent vacancy in the office of Delegate, by reason of death, resignation, or permanent disability, the office of Delegate shall remain vacant until a successor shall have been elected and qualified."

The amendment requires the GEC to conduct a special election to fill a vacancy in the Seat of the Washington Representative <u>only if the vacancy occurs prior to eight months before the date of the next general election</u>. The GEC respectfully notes that establishing an eight-month threshold for a special election to fill a vacancy could leave Guam without representation in Congress for a significant amount of time. For example, if a vacancy occurs after March 8, 2022, Guam would be without a Washington Representative until the new term in January of 2023. While this may not be an issue concerning other elected offices in Guam, the Washington Delegate position is the lone voice for the people of Guam in the U.S. Congress. The GEC is willing to work with the Committee to find a better solution.

The Organic Act also states that the Delegate shall be elected at large by a <u>majority of votes cast</u> for the office of <u>Delegate</u>. The amendment states that the highest vote getter shall be certified by the GEC as elected. The GEC respectfully requests that the amendment be aligned with the majority requirement mandated by the Organic Act.

Bill No. 174-36

Section 1. Amends Section 15201. Primary Election Date. The GEC supports the date change for a primary election. Conducting the primary election earlier allows the GEC additional time to prepare general election ballots and meet other local and federal election deadlines, such as the deadline to transmit absentee ballots to UOCAVA voters.

Section 2. Amends Section 15206. Time for Filing Nominating Papers; Fees. Section 3. Amends Section 6108. Filing of Nominating Petitions. The GEC supports the change to the filing deadlines for the nominating papers described in Sections 2 and 3. The amendments allow more time for the GEC to process candidate packets, remedy issues relative to candidate filings, ratify candidates, and design, print, and mail out ballots to meet UOCAVA deadlines.

Section 4. Amends Section 3104. Times for Registration; Section 5. Amends Section 3105. Place of Registration; Section 6. Adds a new Section 3102.1(g); and Section 7. Adds new Section 3101.3(h).

The GEC supports the changes described in Sections 4, 5, and 6 because the GEC will have ample time to process Affidavits of Registrations to ensure the accuracy and completeness of all voter information. The additional time also allows the GEC to vet and verify voter information and file Affidavits of Registration before certifying the voter registration rosters and further enables the GEC ample time to print out the official voter signature rosters for each election precinct.

Currently, Guam law provides all eligible voters with different options to register to vote or update their voter registration record. Voters can register online, renew or obtain a driver's license through motor-voter registration, volunteer voter registrars in the community, district registration, and in-person registration at our office. Closing registration earlier will allow for more accurate registration rolls, one of the most critical aspects of elections.

Chairman Joe S. San Agustin: Will have you hold off Ms. Santos on the 174 just so that every we just stick with the 173 first I'd like to also recognize Senator Mary Camacho Torres who joined us and we'll begin questions from my colleagues Senator Amanda Shelton do you have any questions?

Senator Amanda L. Shelton: Thanks Mr. Chair I'll try to go in the order of the testimony and the bill it was a lot to take in but I might have more questions towards the end if you come back to me but just a couple of things. Thank you very much for your testimony. Could you expand a little bit up on the typical number of write-in votes that happened during an election?

Elizabeth Santos, Acting Director, GEC: So this is Tom San Agustin we actually have our election comparative analysis report from 2020. So really the number of writing votes vary by race in past elections we have not at least in my time at GEC have not seen a write-in candidate get enough votes to affect the race of named candidates on the ballot but overall in terms of all the ballots cast the number of write-in votes in total are significant when we're sorting and trying to list all the names um reviewing each ballot that has write-in votes but for an example in 2018 there were 80 write-in votes for the office of Attorney General there were let's see if I can give you 2020. In 2020 in the Mayoral race the total number of write-in votes was 1415. so with this the way that the election code is written now GEC would have to review all those ballots that have the write-in the write-in oval marked filled in and then we would have to review the name and publish after we review the names we have to tally all the names and report how many votes each name got and a lot of the times they're just fake names.

Senator Amanda L. Shelton: You'd say majority of the time you're receiving names that don't actually exist I guess I'm most concerned about for example Mayoral votes and the write-ins there how those can make a difference in such a small a smaller race compared to the legislature's race or a Gubernatorial race and how those names are significant and of course to the public wanting to see those names being published if there is maybe some kind of exception that we need to make for maybe a smaller threshold or one to publish a name I don't know that's just an idea a concern that I can see when races are really tight.

So the amended language we would still publish names if the number of write-in votes does affect that race so in races like you said for me Mayoral and Vice Mayoral races we would likely have to publish names if that number is going to affect the outcome of that race.

Senator Amanda L. Shelton: So is there a mechanism for the public to perhaps request for the names to be published at a later date or for them to see to see that for themselves if a candidate was curious or supporters were curious.

Elizabeth Santos, Acting Director, GEC: Well at this point if their request is to review the ballot itself with names and NO, because those ballots have to be sealed but right now because the law makes us publish names there we do publish the names on our website and if this amendment is passed we would have to create a mechanism for people to ask to review the number of write-in votes..

Senator Amanda L. Shelton: Is that something you think you can do I mean obviously you do it right now you publish all of the names but to come up with that that type of mechanism for someone to request the names it is something that you are capable of I'm sure. yes okay all righty thank you very much okay and so I wanted to go to the last section that you were talking about filling the seat of a Washington u have about the eight months prior and leaving that seat vacant if anything were to happen after eight months so I know that you support this with reservation is there a recommendation that the election commission would give to us to make this a better amendment to the law.

Elizabeth Santos, Acting Director, GEC: At this point we're just noting that the eight months is long I guess we would say shorten it but of course that is up to the committee.

Senator Amanda L. Shelton: Okay and can you take us through your timeline of running a special election how many days do you need to get you to notify the public to plan to prepare and to execute.

Elizabeth Santos, Acting Director, GEC: So for the special election after the vacancy has been declared we have to hold the special elections 60 days after that vacancy is declared within those 60 days there are timelines for candidates to file I think in the section in the bill the candidate packet would be due no later than 40 days prior to the special election date and then with regard to other filings such as campaign finance that with regard to the delegate those deadlines are specific from the federal election commission I am not as familiar with those deadlines as I am with local deadlines for campaign finance but there would be filing deadlines for the delegate in a special election as well other than that registration would close 10 days prior to the special election so that we can finalize the voter registration rules print signature rosters and have them ready for the special election date training for precinct officials will happen within those 60 days prior to the election and also our coordination with other government agencies such as GPD and DPW for and DOE for the use of polling sites and the buses that are used to transport precinct officials and ballots to and from polling sites into the UOG so basically in a special election our timeline is within 60 days from vacancy to the special election date and all of those things have to be coordinated within that 60-day period.

Senator Amanda L. Shelton: Okay so we could certainly shorten that eight-month period if the vacancy were to occur within a shorter time than eight months it would just be a pretty tight you folks are used to it you can move fast within your 60-day window it is possible okay so that's something that we'll have to discuss more okay and if I could just go back to the provisional and absentee ballots this change that's being proposed here for the provisional ballots and the absentee ballots can you give us any data about how significant these are to changing the preliminary results that we see that come in on election night if we were to wait to count these provisional ballots and with the absentee ballots later.

Elizabeth Santos, Acting Director, GEC: So with the provisional ballots even without the changes proposed in this Section we do have to wait a certain number of days to process the provisional ballot. The provisional ballot law allows seven days for voters to come in and remedy let's say they forgot to sign the affidavit envelope or they didn't present an ID at the polling site on election day which is why they voted provisional so there already is a certain number of days that it takes for us to process provisional ballots so it wouldn't be like we wouldn't have results for provisional voters on election night really this change would allow us to not count within two days so let's say provisional ballots they are cured within the seven days and they are qualified and so we have to count them within 10 days of the election so for example in the last runoff election we counted provisional ballots for the general election on election night of the runoff and then we had to open the ballots again 10 days after so that we can count the absentee ballots that were received from off island and so these sections really is just to allow us to not have to open the ballot envelopes on so many different occasions we would just like to streamline it so that they're open at once. With regard to the number of provisional voters in 2020 Tom will address this.

Thomas San Agustin, Program Coordinator, GEC: Hi Senator so in regards to affecting the race normally for the absentee we will traditionally wait for about roughly around a little over 150 ballots in the case of the provisional through my experience I've only seen cases of smaller races such as the Mayoral races were the provisional ballot may affect the outcome of the race but so far in our history of doing the provisional it has not affected any of the races.

Senator Amanda L. Shelton: Okay thank you very much thank you Tom thank you Liz for the information today I appreciate it and thank you also to Attorney Vince thank you for being here.

Chairman Joe S. San Agustin: Thank you thank you Senator Shelton Madam Speaker do you have any questions to the Guam Election folks?

Speaker Therese M. Terlaje: Yes thank you and thank you Ms. Santos for being the Acting Director today you and Tom are doing a great job thank you thank you and I like the recommendations that you've made to change the highest vote getter to majority to be consistent with the Organic Act and the other recommendations throughout the Bill so I'm sure the Chairman will consider those if I could just concentrate on Section 1 of the Bill where you talked about canceling the Primary so the bill currently talks about if fewer than maximum number of partisan candidates who can advance to the General Election are running in both political parties and I was wondering how that was going to

be interpreted but your suggestion is asking us to depart from this both political parties and talk about if equal to or fewer than the maximum number of candidates can advance the General Election for any partisan elected office so would that mean this provision allows you to cancel one side for example just

Elizabeth Santos, Acting Director, GEC: No.

Speaker Therese M. Terlaje: not does another provision of law allow that?

Elizabeth Santos, Acting Director, GEC: Currently no.

Speaker Therese M. Terlaje: So if there's a fewer than the number in the Democrat Party for example you would still run an election I mean right now

Elizabeth Santos, Acting Director, GEC: Yes

Speaker Therese Terlaje: run an election yeah and so this so do you think that your language would allow you your proposed language would allow you to cancel it for one side only

Elizabeth Santos, Acting Director, GEC: No.

Speaker Therese M. Terlaje: Okay so it's either all or none we have a primary you're this only this bill only affects whether we have a primary at all not cancel the primary on one side or the other

Elizabeth Santos, Acting Director, GEC: it wouldn't it would be by offers so if we take the legislature for example if the democrats put forth 15 candidates in the primary election and republicans have 15 then only that race would be cancelled if let's say in the Gubernatorial race there is only one Democrat team and one Republican team then that race would be canceled so it would really be by race and then also by off by party.

Speaker Therese M. Terlaje: All right and do you does the do you know the federal race the Washington Representative has any restrictions regarding what we do in a Primary

Elizabeth Santos, Acting Director, GEC: No. The Organic Act does not mandate a Primary Election where it does get where the Delegate Race would be affected is if there are more than one candidate in each party in the General Election it's likely that we would have to have a runoff but there's nothing in the Organic Act that states that the Delegate race has to be in the Primary Election

Speaker Therese Terlaje: All right and I appreciate your suggestion regarding the eight months I'm going to think about that I agree it's a very long period to be without a representative it's a long period to be without any of our elected officials, I think we just have to balance right getting them in there for one month only is it worth it the cost of an election right and if you could just remind us what is the cost of a special election

Thomas San Agustin, Program Coordinator, GEC: Hi Senator so I guess in the case of the Delegate to run an island one election would cost around 300 some thousand I guess you could think of it because there are some fixed costs fixed election costs such as despite how many races are on the ballot we would still have to pay for precinct officials that will roughly range around \$117.000 we will still have to do the same

amount of ballot production also solicit busing services and the usage of the DOE Facilities it really depends on which race and if there's an island-wide we still have a lot of election costs to cover if it's a single race like a mayoral then of course the class will be quite substantial.

Speaker Therese M. Terlaje: All right and then, finally the what's the other on the printing the writing so I'm trying to balance right I think if there is a legitimate write-in candidate they would like to see how many votes they received so I hate to not publish those results. I understand you know we're publishing silly results as well but to not publish someone who actually ran a write-in you know candidacy I would like to publish those for them so I'm going to consider that I guess that and you're saying that the harm in the current statute is that it's just taking it's costly you said and it's unnecessary costs and you want to simplify the process the cost is really you have to look at those names anyways and you have to tally them right they have to be tallied isn't that right

Thomas San Agustin, Program Coordinator, GEC: Yes

Speaker Therese M. Terlaje: So in the end you're tallying them and it's just a matter of publicizing them or not and you said you really don't publish them in the newspaper you publish them on your website?

Elizabeth Santos, Acting Director, GEC: Yes

Speaker Therese M. Terlaje: Okay so I'm kind of inclined that that's the only one I might you know disagree that if you're only incurring the cost of publishing it on your website that I would go forward with it for especially those cases where we have some real legitimate writing candidates and I think we had that in this last election but anyway in some of the Mayoral Races I would like them to see their results, but all right, and Thank you very much Mr. Chair and thanks again to Guam Election Commission.

Elizabeth Santos, Acting Director, GEC: Thank you Speaker.

Chairman Joe S. San Agustin: Thank you Madam Speaker. Senator Telo do you have any questions for the panel?

Senator Telo T. Taitague: Thank you Mr. Chair actually Speaker had all the questions I had with regards to my list but there was one thing that was mentioned first I'd like to thank you guys down at Guam Election Commission for all the hard work that you're doing and appreciate you being here to provide us your testimony which you know will take some time to read since we just got it while you were speaking so we can go over thoroughly and I'm sure you'll answer any questions we have if we give you a call, however there was one question that was brought up with Speaker in the event that there's 15 on each side in the Primary for the Senatorial side then there would be no Election or Primary Election for Senators correct?

Elizabeth Santos, Acting Director, GEC: Correct

Senator Telo T. Taitague: Okay and then but what if the Democrats have 16 running on the Democrat side and the Republicans have 15 do we still have a Primary?

Elizabeth Santos, Acting Director, GEC: Yes a Primary Election would be held for both parties.

Senator Telo T. Taitague: For both parties so it's only in the event I just wanted to clarify it only in the event and you think the language in the legislation is clear about 15 and not anything above because

Elizabeth Santos, Acting Director, GEC: That's why we added the equal to or fewer than yeah so if it in the case of the legislature it would be 15 or less

Senator Telo T. Taitague: yeah, so that's important to put on okay other than that thank you so much I appreciate it okay thank you thank you

Elizabeth Santos, Acting Director, GEC: Thank you Senator

Chairman Joe S. San Agustin: Thank you Senator Telo Senator Brown do you have any questions ma'am.

Senator Joanne M. Brown: Thank you very much Mr. Chair I just wanted to get further clarification with regards to what's required for the Congressional Billing a Congressional vacancy what is required Federally if a vacancy happens seven months before the next election or three months before the next Election what is their requirement because I assume that's what we have to be consistent with if I can

Elizabeth Santos, Acting Director, GEC: Really the only thing the only guidance is the Organic Act that says that the seat remains vacant until another Election there is no time frame established by the Organic Act so that's why we support creating the mechanism to fill a vacancy just so that in the event that there is one you know we will know how to proceed but with regard to Federal Law there really is no time frame.

Senator Joanne M. Brown: Does the Organic Act allow us to Amend to put language in for a vacancy for a Congressional Candidate?

Elizabeth Santos, Acting Director, GEC: Yes, it does

Senator Joanne M. Brown: Okay and one just hasn't been put in place I hope I hope the question's not being raised because we're anticipating a vacancy in the Congressional Seat okay so we are allowed then to set a timeline and this is just making it consistent with what we have for the other elected positions of eight months everyone knows the magic month of march of the year of the election year of the election for a time for vacancy I also the concern raised by Speaker Terlaje I also concur with her that I think we still need to have that published I mean we've known for years you know some people want to put something funny in and put Mickey mouse or Donald duck as their candidate, I don't know why they make all the effort to go to the voting place to do that but for some they have interesting sense of humor but I agree with the Speaker I think that information should still be available to the public you may have other individuals who are being nominated maybe they didn't have an overwhelming number of votes but nevertheless or write in of their name but I think it's important just for awareness and transparency with that information still be made available even if it's a silly name, in all fairness for the voting public and the community to know who wrote who, I think that's important to do since that obviously is the main priority and mission of the Election Commission other than that I don't have a concern with the legislation but I hope we can

at least address those issues going back to the provisional Ballots you mentioned right now your process is you count the votes that are on island first is that how it goes with your procedure you prioritize counting on island votes first and then after is that when you guys open the envelopes for off island votes or how does that how does that all work out in the process?

Elizabeth Santos, Acting Director, GEC: It's not that we prioritize it it's just with the timeline set in the election code now there are specific no there are a specific number of days in which voters can complete their provisional valid affidavits and then also there is a we are supposed to count it within 10 days of the election and so that statute of counting within 10 days and then in a separate statute for absentee ballots we are required to wait until 5 p.m. on the 10th day after the election to accept off island absentee ballots and so it's just because those days are so close together but also can fall you know one earlier than the other provisional earlier than the absentee we just wanted it so that we are tabulating all of them together so that the law can allow us to tabulate it all together

Senator Joanne M. Brown: Okay and then the 10 days I assume it's just allowing because these are people mailing in their ballots from off island just to give them the additional time with the mailing process to send it into to Guam okay I don't I otherwise I don't think I have any concerns with regards to what's been provided but I again just want clarification as was asked by one of my colleagues earlier Senator Telo with regards to so if one party has more than 15 it still will require a primary for both parties

Elizabeth Santos, Acting Director, GEC: Yes

Senator Joanne M. Brown: Let's be optimistic let's say the republicans had 18 and the democrats had 12 just for the sake of hypothetical review here would you still hold a primary for both party candidates would be listed

Elizabeth Santos, Acting Director, GEC: Yes

Senator Joanne M. Brown: and people could still in their primary vote for whoever they wanted to vote for on their respected side of the ballot

Elizabeth Santos, Acting Director, GEC: Yes

Senator Joanne M. Brown: okay I just wanted to get that clarified thank you so much for your participation and testimony on this bill I appreciate your responses and certainly thank you very much Mr. Chairman for the opportunity to ask the question thank you

Chairman Joe S. San Agustin: Thank you Senator Brown Senator Torres do you have any questions for the Election Commission

Senator Mary Camacho Torres: Yes I was just wondering I appreciate the testimony and I a lot of what I was thinking about you had covered in your testimony so thank you very much for that, but in the Election Commission I know that one of the concerns is always how to make the experience for the voter attractive in terms of it being the facility it being easy accessible for them to encourage people to come out to vote register to vote and come out to vote is there anything about this legislation that you think might

be something that discourages somebody from participating in the election process or do you see no adverse effects from this type of reform, I'm just wondering randomly in terms of when we want to encourage people is this does this serve in some way to discourage in your opinion?

Elizabeth Santos, Acting Director, GEC: As a whole no I don't think that it serves to discourage anyone from coming out actually the section on the electioneering boundaries I think would encourage more people to come out making those boundaries clear and keeping the entrance and exits to the polling sites clear of campaigners or signs so that it they can voters can safely enter and exit polling sites. I think would actually encourage more people to show up on Election day.

Senator Mary Camacho Torres: Okay just thought I'd bring that up because that's you know every it's always about facility right what do we do to make the experience something that encourages them to come out but otherwise your answers and your comments I thought were very on point and you know very professionally thought through so thanks a lot for that and keep up the good work

Elizabeth Santos, Acting Director, GEC: Thank you Senator, Thank you Senator

Chairman Joe S. San Agustin: Thank you Senator, Senator Moylan do you have any questions for the Election Commission?

Senator James Moylan: It's really thorough presentation I really want to thank them for this and their recommendations to strengthen the bill my colleagues asked most of the questions as well but there's one thing we didn't really touch on maybe the Election Commission can just clarify, under Section 5 there's a change in the definition under name can you give an example of why this is part of and some things that you have seen and if there was difficulty explaining that to candidates on why this will be helpful for the Election Commission please?

Elizabeth Santos, Acting Director, GEC: So in the past we have had occasions where we receive nominating petitions that have a nickname or some other alias rather than the candidate's legal name and then it was up to the commission to determine whether or not those nominating petition would be counted towards the number of signatures required for office, and so creating this definition or establishing this definition in law would just make it clear to everyone who wants to run for office and also the law requires the legal name of candidates to be on the ballot and so it just makes it clear that all the forms regarding candidates see have to have the candidate's legal name printed and then also we just like to make it clear for everyone because we know that the second identifier line on the ballot is important to candidates we want to make it clear that this section won't change that it's just to make sure that the candidate's legal name appears on all the documents on all the documents for candidacy and it also encourages transparency for the electorate.

Senator James Moylan: Thank you very much Mr. Chair I have no other questions and I really appreciate the presentation today I agree with their opening statement especially that saying these types of modernization acts it's fair, it's honest, it's open and it's making it more efficient and effective as possible. So hopefully that helps us to gain more folks

coming out and voting eventually so Thank you to my colleagues and Thank you to the Election Commission Thank you Mr. Chair.

Chairman Joe S. San Agustin: All right Thank you Senator Moylan there being that there's no other individual Senator Telo

Senator Telo T. Taitague: Just real quick Mr. Chair with regards to the publishing of the you know the names that are going out I know that is there anything in the is in this legislation that prohibits you from doing it publishing in the paper versus online are you most likely going to do online then you know save money and instead of publish it in the paper the only reason why is we have a lot of manamko' who don't have access to online and many of them are if you look at your count many of them are all voters you know they're they they're probably the mass voters coming in but they don't have access to online, so is there any way the this legislation or you have any issues of ensuring that this is published you know in the paper for them to see than online

Elizabeth Santos, Acting Director, GEC: Yeah nothing, nothing prohibits us from publishing in the newspaper, the other sections in the election code actually require us to publish the qualified candidates in the newspaper with regard to the write-in votes, we publish on our website as a cost-saving measure but nothing in the election code will prohibit us from publishing in the newspaper.

Senator Telo T. Taitague: Okay I hope that you guys maintain that for now you know please still not totally gone techy all the way so especially thank you so much, thanks Mr. Chair just wanted to verify today

Chairman Joe S. San Agustin: Thank you Senator Telo for making that clarification and thank you very much for making that statement we will continue there's no one else to testify we'll continue the committee continue to submit to receive testimony and please submit the testimony to the mailroom of the Guam Legislation, through email senatorjoesanagustin@gmail.com that being said again I'd like to thank everyone for attending this virtual public hearing and for providing feedback and suggestion on Bill 173 the Public Hearing is now adjourned time now is 10:46 we will now continue on this hearing now, but we're going to address bill 174 continuation of the election commission bills and with that a reminder we're still on track.

The Virtual Public Hearing is adjourned at 10:46 a.m.

III. Findings and Recommendations

The Committee finds that the Guam Election Commission had proffered amendments during the Public Hearing on Bill 173-36 (LS), which the Committee and the Main Sponsor of the Bill had accepted. The following amendments had been placed into the Substitute bill in accordance with the Guam Election Commission Testimony:

- a. Section 1. Cancelation of the Primary Election for Certain Circumstances, the GEC requested to amend the language to, "In any given election year, the Guam Election Commission shall cancel the Primary Election if equal to or fever than the maximum number of candidates can advance to the General Election for any partisan elected office."
 - a. The GEC recommended that the Primary Election be cancelled for the nonpartisan offices such as the Office of Public Accountability and Attorney General, which increases election costs substantially because of the cost of printing a separate nonpartisan ballot and the amount of time it takes to tabulate the separate ballots.
 - b. The Committee had accepted the language provided by Guam Election Commission.
- b. Section 2. Amended Section 11115. Write In Votes. The Guam Election Commission supports the amendment of not having to publish the name of the write-ins if the total votes of the write-in candidate do not change the vote tabulation for the write-in candidates. This allows the GEC to cut on cost mostly if such write-in candidates is named "Superman" and "Mickey Mouse." The language of the introduced Bill requires the GEC to report the total number of write-in votes tabulated but only requires publication of write-in votes names if the number of write-in votes affects the outcome of the race. The GEC recommend amending the language to maintain clarity, which was accepted by the Committee.
- c. Section 3. Amends Section 9112. Electioneering at Polling Place Prohibited. According to the Testimony provided by GEC, they are in support of Section 3, but recommended the language to be used, which the Committee had accepted.
- d. Section 7. Amends Section 13103. Election to Fill Vacancy in I Liheslaturan Guan or the Seat of the Washington Delegate. The Guam Election Commission had voiced out that they had reservations to the amendment of the introduced bill which seeks to provide a mechanism to fill a vacancy in the Seat of the Washington Delegate. The removal of the period of eight (8) months was accepted by the Committee with the support of the Guam Election Commission. If such vacancy occurs for the Seat of the Washington Delegate, a Special Election shall take place and the candidate with majority votes casted shall be certified by the Guam Election Commission as elected. The amended aligns with the Organic Act, which the Committee accepted and included into the Substitute Bill.

1/: In its current form, the intent of the subject legislation is to address and modernize election-related issues inclusive of write-in votes, counting provisional ballots, electioneering at polling places, the cancellation of the primary election in certain circumstances and vacancies. If the Bill were to become law, should a primary elections not take place for certain contests, there would be a potential decrease in personnel cost, particularly in overtime. It should be noted that overtime cost incurred by the GEC averages approximately \$100K per year between FY2017 to FY2021 Year-To-Date. The GEC has indicated that should the Primary Election be cancelled in totality, the potential cost savings would be approximately \$365K.
