

1. OVERVIEW

Bill No. 187-36 (COR) was introduced on **September 08, 2021** by Joe S. San Agustin and Telen Cruz Nelson was subsequently referred by the Committee on Rules to the Committee on **General Government Operations, Appropriations, and Housing** on **September 14, 2021**.

The **Committee on General Government Operations, Appropriations, and Housing** convened a virtual public hearing on **Bill No. 187-36 (COR)** on **Thursday, October 07, 2021 @9:00a.m.** via Zoom Virtual Conference Platform.

II. SUMMARY OF TESTIMONY AND DISCUSSION

The Public Hearing was Called-to-Order at 9:01a.m.

Chairman Joe S. San Agustin: Thank you and *Håfa adai* everyone, the committee on General Government Operations Appropriations and Housing is now called to order, for the record today is Thursday, October 7, the time now is 9:01 a.m. Welcome to everyone connected by zoom and those tuning in via television or the youtube channel, thank you for your patience and for accommodating this zoom platform while we maintain social distancing mandates. Notices for this public hearing we're disseminated via email to all senators and all main broadcasting outlets on Wednesday, September 29, 2021 and again on Tuesday, October 5, 2021

The agenda for the following bill will be heard between nine and ten, would be **Bill 187-36** introduced by myself co-sponsored by Senator Telena Nelson – **"AN ACT TO APPROPRIATE THREE MILLION FIVE HUNDRED THOUSAND DOLLARS (\$3,500,000) FROM THE 2021 EARNED INCOME TAX CREDIT REIMBURSEMENT TO THE DEPARTMENT OF PARKS AND RECREATION STATE HISTORIC PRESERVATION OFFICE FOR THE PURPOSE OF CONSTRUCTING THE *NAFTAN / MAÑAINA-TA*, A SACRED BURIAL GROUND FOR THE DIGNIFIED RE-INTERMENT OF GUAM'S ANCESTRAL REMAINS"**

And I have to appropriate three million five hundred dollars from the 2021 earned income tax credit reimbursement to the Department of Parks and Recreation state historic preservation office for the purpose of constructing the *Nafta Mananata*, a sacred burial ground for the dignified reinternment of Guam's ancestral remains. I'd like to write the Bill 196-36 by myself, senator correction let me back up that was 196, we're still in 187. *Håfa adai* and good morning colleagues and to the people watching us via youtube and channel TV today, we are here to discuss Bill 187. The bill provides funding to the Department of Recreation state historic preservation and providing our answers a permanent barrier of sight. It is in our custom that we honorably bury loved ones for the almost dignity and respect as our island navigates through evolving times, modernization and globalization has tremendously made an impact on our island as we see, continue to modernize developments have increased the lands that once was a home for many of our ancestors no longer in act due to lack of funding.

Over 3,000 ancestral remains have been distributed from the original resting place were this in turn due to military, local and private development. It is just that we provide our ancestors for a proper re-internment and a permanent dignified burial ground. They deserve respect of a proper burial ground and internment as they pave the way for our island and on our culture. I have also a statement from my co-sponsor Senator Nelson, her statement states, *Håfa adai* when is an in May 1992, Public Law 21-104, was enacted to establish a *Chamoru* shrine called the *nafta marinata* for ancestral remains found around the island. It wasn't until December 2016 that Public Law 33-204 was enacted to reserve a five-acre portion of land until Tamuning at Ypao point.

Today, it is my great pleasure to co-sponsor **Bill 187-36 COR** to construct the *Naftan imani nata* that has been long overdue. This project has taken decades to complete and the

remains of our ancestral. Have been disturbed from the original resting place; there are over 3,000 remains stored inside boxes all over the island, the line of descendants from these animations are possibly here joining us today.

We must pay them and their families the respect they rightfully deserve and lay them to rest in peace that's the statement from Senator Nelson, my co-sponsor.

We will now read off the general rules of conduct.

I'd like to thank my colleagues for attending this morning's hearing. I'd like to recognize that we have Senator Chris Dueñas, in the audience, the minority leader, we have Senator Brown, we have Senator Telo Taitague, we have the Speaker also here Senator, Speaker Therese Terlaje, we have Senator "Pedro" Terlaje, chili and with that I would ask that we have Mr. Patrick Lujan from Parks and Rec the shippo office, asked him to first speak, he's the only one here currently to testify in support of the bill. I would assume all right Patrick, you're on now.

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation:
Thank you so much, great thank you, thank you Senator and good morning, Senators that are all present, greatly appreciate your attendance and attention to this matter for quite some time you know, this has been an endeavor for this office, to have a final resting place of our ancestors. Some of the remains have been unearthed for over a hundred years. Those have been within the know of the situation going back to what is famously

called the horn bustle collection, has been on earth and on shelves pretty much for over a hundred years so, now we are at the stage where we can finally see then completion and the reinterpret of these remains of our ancestors is a great feeling for myself and for the office here and for my you know, I'm sure all the predecessors before me, that worked in this office. We had just completed the design phase, which just expired on September 30th so, we went through the whole design concept within the last couple of years with the finalization just last month so that big portion and that big movement is a step in the right direction. You know and I'm so glad that senators San Agustin, Senator Nelson the Speaker have been champions of this and I'm sure everybody, the other senators that are online right now feel the same way that we finally see the light so, to speak at the end of the tunnel, we did with the design phase come up with a hard estimate of about three million dollars (\$3,000,000.00) for the building of it. The only thing that is incomplete so far is the actual inventory of the remains, the number of 3000 remains is a rough estimate however, before we do the actual reinterpret of our remains, we would like to get an accurate inventory and so with that.

I was speaking with your office Senator San Augustin, for a little bump up to the proposed budget of this to go up to 3.8 so an additional hundred thousand dollars is a request from my, for myself, and for my office this will allow us to get the most accurate inventory of human remains that we have and then make the proper decisions. I know we have been writing off of the executive order of 89-34 since governor Ada's time that pretty much gave a hard line of what remains should go into the *Naftan imani nata* and what remains should be re-entered closest to the findings of post-1989 but since then, there has been developments and where there would be situations post-1989b that we would not be able to find the responsible parties to conduct the proper reinternment closest to the findings so in those instances a proper inventory will give us accurate information and in those cases we can make amendments to that to properly re-enter them into the *Naftan imani nata* I manufacture so right now my staff is working really hard to try and come up with some type of deliverable when in regards to the inventory working closely with Melvin Won Pat Borja, his staff over at the museum who is holding majority of the human remains as we speak and you know to come up with that with an accurate inventory and that way we can finalize the conception on the crypts of within the *Naftan imani nata* so in that tone I would respectfully request for an increase of three hundred thousand dollars hopefully that would be the ceiling for a property in proper inventory, thank you.

Chairman Joe S. San Agustin: Thank you Mr. Lujan, I really appreciate your testimony a reminder this is 3.5 million funding so I think we're in line and if we need to make the adjustment Mr. Lujan, please provide us the information before we send this bill forward all right, we'll be in contact with your office. I know as I don't see anyone else that's going to testify but I'm going to ask we'll begin with Speaker Terlaje, if you'd like to ask any question of Mr. Lujan?

Speaker Therse M. Terlaje: Thank you, Mr. Chair, Mr. Lujan, thank you for your testimony and for your efforts in regards to the re-burials, can you just talk about the staffing that is also covered by this bill?

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: Yes, thank you so, in a previous audit with the challenges that have been faced within our office you know a previous audit has showed us that we had a shortfall of staffing, you know with at least six people if not more but I've broken it down to where all the taskings and all the requirements can be conducted with an additional six people so we have presented to the committee and to Senator San Augustin's office, for the extra five hundred thousand dollars (\$500,000.00) that will fulfill the requirements just to take us to a proper level and threshold working with all the complexities of our office you know from the military to the private to the government projects working with all the permits and the research, its research, intensive office that we have here and that will take us to the proper leveling for staffing so that that explains the additional six bodies which includes a GIS expert. Another archaeologist, a librarian if you look at the data and the historical filings that we have you know we got to come up to speed with that so those I have always already been analyzed and studied and we've already got it down to almost a science as far as what the required positions that we need so thank you for that question.

Speaker Therse M. Terlaje: All right, thank you so that would be according to the bill it's \$300,000.00.

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: Yeah, I think that's an error it's, \$500,000.00 for the extra six so that's why it came out to \$3.500,000.00.

Speaker Therse M. Terlaje: Thank you, so that \$300,000.00 on the bill is it's an error so that brings us to 3.5 and then I'm asking for an additional 300 for the inventory to make it 3.8 total all right and the sixth person now would be local funded right and then could you just remind us most of your office is federally funded is that right it's half so we've the current budget that we have and the current salaries that we have is just under a million dollars about \$900,000.00 and so about 55 local 45 from the national park service historic preservation fund 65.45 all right and this appropriation maybe Mr. Chair, you can clarify going forward this is a one-time appropriation for it just looks like a one-time appropriation so it looks like if you do pick up those personnel we need we will need to find you know how to fund that going forward and I guess Mr. Chair, I have no other questions. I support this bill. I want to see these re-burials you know occur as planned and I want the additional personnel in the office. I think it's very critical right now. I think it's been critical for years and it's actually really harmed us to not have enough personnel in this office, and but one I want to know, I guess DOA is not here. I wanted them to confirm again that just a funding source, it talks about reimbursement for calendar year 2021 and I think we talked about this during the budget as to you know we what reimbursement. We will be receiving for 2021 I'm hoping that this bill doesn't eat into the amounts that we've already finished allocating for the hospital and the prison and of course the refunds and I guess.

Chairman Joe S. San Agustin: You're correct.

Speaker Therse M. Terlaje: All right so thank you and thank you Patrick, Mr. Schiphol thank you, thank you.

Chairman Joe S. San Agustin: All right and thank you madam, Speaker for that question I'd like to also recognize Senator, one has joined us but in reverend, it's a one-time funding and I do acknowledge that for continuation when we go into budget year FY2023 then we'll be able to identify that in the budget process. One thing I would like to mention is that when we identify identified 2021 calendar year. I don't know my colleagues should have had a copy of that, it would identify that the FY2022 budget is really set. It's set and 2022 we're talking about calendar year 21, from January of 21 to December 21, if we the people of Guam pay any earned income tax credit or even CTC, child tax credit we're entitled to reimbursement that was based on the law that was passed by congress signed by the president, all I'm saying and all we're doing on the bills that are coming forward is to identify that the government is to go back and ask for reimbursement for this year, if most of the folks, my colleagues are familiar with the title 30 the any time that Government of Guam goes back to the Federal Government says we need to reconcile they find out that either they pay them too much or we're entitled to more money this on this program as we're identifying the reimbursement of 21, keep in mind we're not talking about 2022. I think San Antonio had brought it up at one time that are you referring to maybe tax year 2020 well when you look at the calendar year 21, it would be inferred that it is reimbursement for what we paid for the remember payment for tax year 2020, so that would fall in line to exactly what Senator Tello had brought about one time, I will now move on to, we have also Senator Mary Torres has joined us on ask now Senator Pedro Terlaje if you would like to ask any question of Mr. Lujan, then we'll move to Senator Chris Dueñas, you're on mute, you need to turn on your mic, turn on your mic.

Senator Jose "Pedro" Terlaje: Can you hear me now?

Chairman Joe S. San Agustin: There you go.

Senator Jose "Pedro" Terlaje: Okay, Mr. Chair, all I wanted to, I just wanted to ask Patrick on the definite location you know and because I am in support of this bill but I want to know to mention something about somewhere in over in Ypao. I just wanted to the definite location.

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: Yes, sir so, by law I think this is back to Senator Tom Ada's time, that they allocated five acres within the Ypao point, for the monument so we for the last maybe a year and a half we've been working with Joe Borja over at land management to solidify that piece of property that oversees right above the Hilton land area and with the buffer zone so I would I can share with the committee and with and all the senators the final plotting and the map of that so that's that has been a process that we've been working on as well.

Senator Jose "Pedro" Terlaje: Okay, thank you, thank you Patrick, thank you very much.

Chairman Joe S. San Agustin: Thank you Senator Pedro, Senator Chris Dueñas, do you have any questions for Mr. Lujan?

Senator Christopher M. Dueñas: *Si Yu'os ma'ãse'* Mr. Chairman and colleagues' Pat thanks for being here today and appreciate your testimony. I just wanted maybe to be a little bit more abundantly clear you you've stated with the planning and everything else. I mean what you've articulated it's pretty much that. This is what would we considered almost a shovel ready project and now you've just confirmed the land has been surveyed and that is also you know ready to go I just wanted to make sure we get that on the record so can you confirm that?

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: Yes, that's confirmed so as I mentioned, a previous law funded the design phase for a hundred thousand dollars and so that has been in the works for the last couple of years and that project has just been completed as of last month so it you know for the exception there's just one area within the project and that's the actual allocation and where because what the tomb space will be would be within the design phases from the original ancient village of where these bones, the remains have come from so, that will be decided by the Inventory. The proper inventory that we're going to have and then that will solidify the positioning and the naming of the of the tombs with the ancient villages like you know Hagatna you know, instead of just Tumon or whatever so we're going, we're taking that angle of reintering them within their ancient CHmorru villages.

Senator Christopher M. Dueñas: Thank you Pat and this is certainly the right and dignified thing to do. I want to thank you and your team for the work that you've put forward Mr. Chairman, in closing I just want to thank you for taking my meeting yesterday with the OFB chairman to go through and once again understand what the funding source is here and what was articulated to me from Steve was very clear that tax year 2020 which we appropriate in 2021 for refunds and anything in 2021 that was repaid or was paid for EITC and act is available for appropriation based on reimbursement. We don't know what's going to happen going forward in terms of the 2022 that we just appropriated legislature set forward its priorities but we don't know what that reimbursement is going to look like as was mentioned during the committee of the whole. That may be a trust fund and then it's going to be up to the Governor to abide by the laws that we passed but currently I thank you and OFB's very clear demonstration of this funding source being viable correct upon reimbursement *Si Yu'os ma'ãse'* Mr. Chairman.

Chairman Joe S. San Agustin: Thank you, Senator Duenas for joining us. I will now move to Senator Telo and then you'll be followed by Senator Brown, ma'am.

Senator Telo T. Taitague: Thank you Mr. Chair, Mr. Chair it was clear during the public hearing in the committee of the whole that Daphne Shimizu made it clear that any reimbursement we're getting is for tax year 2021. So, you know there's an argument back and forth and I'm not going to linger on it because there is no funding for 2020 based on what Daphne Shimizu from Revenue & Tax has mentioned so I am concerned about this you know funding for this particular measure and I just tell like I did other people who have been brought before us during a public hearing advocating for a bill that is obviously going to appropriate funding toward them that the reality is the money, is not in our hands at this time now this bill I totally support the intent of this legislation however it's the funding that's an issue on how we're going to fund this and you know Patrick, I don't know how much how far back you researched when it comes to any of these you know the remains and the internment of these remains back to the executive order by you know that was issued by Governor Joe Ada, **Executive Order 89-24**, how they first recognized this and if I'm not mistaken **Public Law 33-204** which gave Oka Point the five acres but not less than two acres on lot number **5173-1, R2** new four next to *Sagan Katura Chamoru* lot is the proposed site for the location identified for **33, Public Law 33-204**, now is that where the intention is on this building? Of the building going to be in at Oka Point?

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: Yes, ma'am it is and the design has been in place for that specific location so that has been solidified already.

Senator Telo T. Taitague: Okay, then Patrick are you aware of a letter that was, it was an agreement between Parks and Rec and Ancestral Lands LLC, who offered in this letter, an agreement signed by both the Director and Wang, Sue, Manager of Ancestral LLC that in this letter of agreement they would fund the entire construction of the final design of the burial site approved by DPR and other entities at no cost to the Government of Guam. Are you familiar that the agreement was signed on October 11, 2018? Are you familiar with that?

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: I am and that letter has been a topic of discussion with land management and so forth So, we have looked into that and I think that deserves a sidebar discussion. I don't want to talk out of tune because that was, I wasn't a part of that agreement so, I know there has been you know speaking with land management and other entities that you know I'm not sure if that is a possible route for whatever reason so definitely interested to talk more on that. I am familiar with it but not in depth.

Chairman Joe S. San Agustin: Senator Telo, you've been muted, turn it on, okay, there you go.

Senator Telo T. Taitague: So, Mr. Chair, my question is, are you, if you haven't had the opportunity, I'll be happy to have my staff forward you this letter between Ancestral LLC

and Department of Parks and Rec regarding the funding, the full funding of this of the burial site design and it's specific to the name *Naftan, imani nata*, specific to this so I'll have them send that to you as well.

Chairman Joe S. San Agustin: Please, I appreciate it.

Senator Telo T. Taitague: And it was October, signed in October of 2018 and this is an opportunity fully funded that can pay for this.

Chairman Joe S. San Agustin: All right, that that sounds great, thank you.

Senator Telo T. Taitague: The legislative intent specifies approximately 3,000 remains and it was said that you're still doing the research and is this going to incorporate other remains stored at *Kaha* still? We have the bishop museum to consider at the bishop and any other you know private architectural engineers, DOD the mark at University of Guam?

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: Yes, so, the intent of the comprehensive inventory would be just that to get the most accurate inventory that Guam has ever had regarding human remains so, I've already sent out a letter to all the archaeological firms to see what they have in their inventory if they have any human remains that that they are holding on to you know, I did the same thing about two years ago when it for when I came back into the office and so I'm getting an updated response from them so, that is all you know in connection to where we want to have the most accurate inventory to see which ones will be going into this national final resting place.

Chairman Joe S. San Agustin: All right, Senator Telo, you're muted.

Senator Telo T. Taitague: I'm not sure it's doing it all by itself, Mr. Chair, not sure why it's doing that but Patrick, one last question how does the burial shrine relate to the current ancestral cultural respiratory built at the University of Guam, how will it relate and will the ancestral remains be reinterred at that facility too?

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: No, the intention is not to have any human remains at the repository at UOG that should be only for artifacts and whatnot so the all-human remains should be reentered be insured.

Senator Telo T. Taitague: Okay so this coordination between historical preservation and DODEA, DOD okay so it has moving so it's not put in there okay, for now Patrick, I wish you very best and I thank you that you continue to look at forth in the intention of **Public Law** that was implemented, Senator Tom Ada was the one that did that legislation, if I'm not mistaken to identify the location and to move forward but please let's look into the letter from the Ancestral LLC and if their ability to pay for this and to oversee this would

be a great help to the Government of Guam and definitely to pay homage to the people of Guam and to keep remembering who they are and where we came from so thank you Patrick, thank you, Mr. Chairman.

Chairman Joe S. San Agustin: Thank you Senator Telo, Senator Brown, do you have any questions for Mr. Lujan?

Senator Joanne M. Brown: Thank you very much Mr. Chairman, not so much questions I mean I'm very supportive of the intent of this bill to address you know the re of our ancestral remains. Obviously, this has been an issue that's been long-standing but I also echo the concerns that were raised by Senator Telo and I don't know if we should put at the entrance of the legislature a scale that tells us how much of this tax credit funding that we are appropriating and what's going to be left since so far, the looks like the number of bills introduced to spend the money has been going to exceed what money is available and that is my concern. I want to make sure that as we're moving forward especially Mr. Chair as I've mentioned time and time again, we don't know what's coming financially, what impact we're going to have in our community with this continued pandemic and what is becoming a continued decrease of federal funding coming into the island so I'm not so much for running around and spending as much money as we possibly can.

I did support the hospital and the construction of a new prison because I understand that's critical infrastructure that we need and I also recognize that this bill is addressing a very important issue that's been long-standing but I also want to make sure that this is legitimately money that will be available and in comparison, to other critical needs of the Government of Guam so I have no issue with that. I did have the opportunity when part of the ancestral main collection was at the bishop museum, I understand that most of that at least, what we had toured has been returned but it's quite an experience to have to go and see our ancestral remains and be able to look at him directly and not have those remains in our own homeland but you know I'm having to go to Hawaii and go to the bishop museum to see that so I have no argument about the need to address re-interment and properly address respectfully the reinterpret of our ancestral remains I just want to make sure financially that the finances are there and that in comparison to other critical needs of our government that this is a responsible appropriation so with that Mr. Chair, I no further comment on this bill, thank you.

Chairman Joe S. San Agustin: Thank you, Senator Brown, Senator Jim Moylan and you'll be followed by Senator Mary Camacho Torres, Senator Moylan.

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: Can I just say something really quick in line with what Senator Brown said was during the design phase over the last couple of years you know it was well thought of how you know, what the purpose of the shrine is, how it's meant for a solemn time, reflection, prayer and not necessarily somewhere to hang out and so with the intent of that, you know we for

you know we've actually cut you know the like utilities and water and bathroom and whatnot with that because you know we took into account the time of the visit of how long a person would actually go to the shrine and visit, is there need for restrooms and whatnot so those have been extracted from the design and I know that plays in line with you know the finance of it so I just wanted to share that with you that you know even those types of planning and thoughts were put into the design phase

Chairman Joe S. San Agustin: All right thank you Senator Moylan, do you have any questions for Mr. Lujan?

Senator James C. Moylan: Thank you Mr. Chairman, Mr. Lujan so, you mentioned the five acres, just for me to visualize is that five acres facing towards Hilton side or is it facing toward Agana side?

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: Which it's facing the Hilton, it's right above the Hilton and so the you know again going back to the design phase it's most of the remains that will be reinterred in this came from that beachfront what we call today is two months so it kind of there's a you know there's a meaning behind that with them kind of facing where they came from and it's a real a real neat design where it's actually going to be off the cliff. I like I said I'll share I'll show the design with all senators and the public we'll put it on our website since it's finalized and it's a real neat design where you know the reflection is that those that were you know taken from their final resting place will kind of see outside to Tumon bay so, it's going to be a really a nice one.

Senator James C. Moylan: Thank you, and after the five acres usage what's the remaining acres there that is still available?

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: That I cannot speak on behalf of that, I would refer that to Mr. Joe Borja at Land Management as the what the next usage is for the surrounding area.

Senator James C. Moylan: Okay, thank you Mr. Lujan, thank you Mr. Chairman.

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: Thank you, Senator.

Chairman Joe S. San Agustin: Thank you, Senator Moylan, Senator Torres, ma'am.

Senator Mary Camacho Torres: Good morning, Mr. Lujan, very interesting discussion and I know that we're going to be very curious about the plans and what has actually been designed, my curiosity about this was, has always been about the inventory and whether this design also contemplates any future fines that are not deemed to be preserved in place but actually have to be removed so I was wondering though, does this design then

accommodate for those future ancestral remain finds the *Naftan, imani nata* or is it intended to be a reinterpret and a monument that begins and ends with what has been extracted to date?

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: Good question Senator, so based off of that executive order in 1989, that is pretty much has been the cutoff period of what would go into the *Naftan, imani nata* and what will not again there's going to be some gray areas because of what I mentioned earlier, some projects that were post 1989 that either the contractor or the archaeological firm or whomever is no longer in existence so we have to be amendable to those however since then any types of findings. The executive order requires that those are reentered as close to the finding place as possible so that's where you see, you know, reburial monuments over at you know Fiesta Resort at NIKKO down at Elite Bridge, and you know we're dealing with not only private sector but also like federal highways, GTA all of these you know down at we're working with GPA on their project that they found Human remains in the Malasso so, we're working with these entities to have reinterpret shrines as closest to where they were found so this monument that is being built is pre-1989 you know majority horn bustle collection 1950, 1921 remains that were unearthed and then knowing based off of the proper inventory that we're also wanting to fund with this bill would determine those gray area remains as mentioned willing to put into the *Naftan, imani nata* method.

Senator Mary Camacho Torres: Okay and it makes total sense in terms of what the internment concept or re-internment concept is, just a follow-up question, is the policy though of shipping more leaning more towards preserving in place as I mean, I would think that that the ultimate sign of respect would be you know remaining in place as opposed to extraction right? Is that a general ideology?

Patrick Lujan, State Prehistoric Reservation Officer, Department of Parks and Recreation: Yes ma'am, yes ma'am and you know that is, we've seen success stories most recently you know campgrounds is where we fought for, our preservation in place you know they moved their parking lot where initially where they were supposed to build and they're going to you know they left the remains there and building a monument around that so that's one of the success stories when we when we fight for preservation in place in those Regards, yes.

Senator Mary Camacho Torres: Thank you for helping us to better understand the concept I appreciate it, thank you Mr. Chair, that's all I just had some random thoughts all right

Chairman Joe S. San Agustin: Thank you, Senator Torres and thank you to my colleagues that are participating today and again Bill 187 and thank you Mr. Lujan and we will be getting with you so we can make the appropriate amendments that we need to make on this bill to ensure that you get the proper staffing and the sufficient funding all right. Patrick, thank you for participating thank you senators this is pretty historic in nature reinterring our ancestors so I appreciate all your support on this all right thank you aga

Bill 187-36 (COR) will provide a funding for a dignified and proper burial ground for our ancestors who were disturbed from their original burial grounds due to modern development. As a CHamoru man, I truly believe it is right that we uphold our treasured custody to honor me, bury our ancestors with dignity and respect, *Si Yu'os ma'åse'*. We will continue to receive testimonies to the mailroom of the Guam Legislature statue at the Guam Congress Building or through email at senatorjoessanagustin@gmail.com. Again, I want to thank everyone for attending this virtual public hearing and for providing feedback and suggestion. This virtual public hearing is now adjourned it is now 9:42a.m. *Si Yu'os ma'åse'* and we will continue on at 10:30 with Bill No 196. Please have a nice day and be safe.

Section 1. Legislative Findings and Intent.

I Liheslaturan Guåhan finds that one of Guam's infinite and treasured customs is to honorably bury loved ones with the utmost dignity and respect.

I Liheslaturan Guåhan further finds that over three thousand (3,000) remains have been disturbed from their original resting places and were disinterred due to military, local and private development.

I Liheslaturan Guåhan further finds that in order to fulfill the commitment and honor we hold dear for our loved ones, the people of Guam must construct a dignified burial ground to re-inter the remains of our ancestors and provide the Department of Parks and Recreation State Historic Preservation Office with personnel support to accomplish this.

1 *I Liheslaturan Guåhan* further finds that the federal government authorized
2 reimbursements for Guam in the Earned Income Tax Credit program in 2021.

3 Therefore, it is the intent of *I Liheslaturan Guåhan* to appropriate Three
4 Million Five Hundred Thousand Dollars (\$3,500,000) from the 2021 Earned Income
5 Tax Credit program reimbursement to the Department of Parks and Recreation State
6 Historic Preservation Office for the purpose of constructing the *Naftan i Mañaina-*

Comments on Bill No. 187-36 (COR)

The proposed legislation seeks to appropriate Three Million Five Hundred Thousand Dollars (\$3,500,000) from the Earned Income Tax Credit (EITC) reimbursement for calendar year 2021, pursuant to Chapter 42 of Title 11, Guam Code Annotated, the Earned Income Program, to the Department of Parks and Recreation (DPR) State Historic Preservation Office (SHPO) for the purpose of constructing the *Naftan I Mañaina-ta*, a sacred burial ground for the dignified re-interment of Guam's ancestral remains.

Based on comments received from DPR, the department fully supports the passing of this bill, but does not address the fiscal impact of its enactment. Additional comments from the Department of Revenue and Taxation (DRT) concludes that the department has paid to taxpayers of record an average of \$53M in EITC reimbursements since 2017 and that Bill No. 187-36 does not affect this funding source nor impact the operations of the department.

The Bureau notes that several proposed legislations have been introduced appropriating funds from the FY 2021 EITC reimbursements, including two which have been included in the FY2022 Budget Act (P.L. 36-54). The current list of proposed Bills are as follows:
