# 10K more vaccines, mostly J&J, arriving this week

The government expects to receive this week 10,840 additional COVID-19 vaccines that are mostly the single-dose Johnson & Johnson Janssen, boosting the government's goal of fully vaccinating at least 62,500 adults by May 1 to reopen tourism and lift post-travel quarantine.

And this week, residents have more options to get vaccinated.

George Reyes, 61, opted for his first dose because he wanted an additional layer of protection for his mother, a World War II survivor, he said.

"I came back to take care of my 86-year-old mother," Reyes, who recently returned from Florida, said.

Reyes was among those who got vaccinated on Monday at the Our Lady of Assumption Church in Piti, the latest village-based vaccination clinic by the Department of Public Health and Social Services.

"We always put family first. She's the family matriarch and we want to be able to take care of her. She took care

of us and raised all of us to become productive members of the community," Reyes, a retired Air Force aviation specialist and a retired federal government employee, said.

The oldest of five siblings, Reyes hopes that more people will avail of the free vaccines for Guam to rid of the pandemic that's caused a lot of hardships.

Chalan Pago resident Michael Binuya, 43, and his wife Jenney, took their second Pfizer-BioNTech dose, in the hopes of providing a safer home for their 4-year-old and 10-month old children.

"We do it for our family. We all have the option to help Guam move forward, by taking this vaccine," the father said.

## More vaccines

Krystal Paco-San Agustin, the governor's director of communications, on Monday said Public Health ordered additional 10,840 vaccines that are expected to arrive later this week:

- 8,500 doses of Johnson & Johnson Janssen
- 2,340 doses of Pfizer-BioNTech

These are in addition to the 53,170 doses that arrived on the first week-end of April.

As of Saturday, 38,705 residents who are at least 16 years old have been fully vaccinated.

That means 23,795 more or about 1,250 a day must still be fully vaccinated to meet Gov. Lou Leon Guerrero's Path to Half goal by May 1 to reopen tourism and lift post-travel quarantine.

## Parents and kids

Willy Magdalera, of Asan, took his 16-year-old daughter Aubrey to get her first vaccine on Monday in Piti.

- Hyatt Regency Guam, from 4 to 7 p.m., Wednesday, in collaboration with the Guam Hotel and Restaurant Association.
- Gov. Joseph Flores Memorial Beach Park, or Ypao Beach, main pavilion, 9 a.m. to 2 p.m., Friday, for homeless individuals.

"Looking at the odds, it's better to get the vaccine as a protection rather than not having any at all. And the pope also said it's okay to get vaccinated and we trust the pope," Magdalera said.

His daughter, a sophomore at the Academy of Our Lady of Guam, said among her friends, she's the first one to take the COVID-19 vaccine.

"I'm setting an example. For me, this gives me an assurance that I am more protected from COVID-19," she said.

Piti resident Michelle Perez, 52, also took her 16-year-old son Rees to get his first vaccine.

"I got fully vaccinated in February as someone who works in a law enforcement agency. But before that, I was on the fence line whether to take it or not but my husband convinced me that it's better to get this added protection," she said.

Thank you for the opportunity to provide testimony on Bill 65-36.

Bill 65-36 proposes to remove the expiration date from Removable Windshield Placards which are issued to individuals with permanent disabilities and to extend the validity period for a Temporary Removable Windshield Placard from six to twelve months.

DRT does not oppose the bill. Our team has already begun to discuss this bill and to prepare for any necessary adjustments we would have to make to our placards to reflect any changes in the law.


We do recognize that most especially during this public health emergency that to extend the temporary removable windshield placard would be beneficial to both the members of our community and to the DRT team due to the limitations we have faced with trying to address public facing services.

In the limited research that we have done, we have not found a jurisdiction that has a non-expiring placard and so there may be a need to work with some of the researchers from the legislative team to determine if additional language should be included to address any potential issues which we may not be aware of at this time – for example – how to address a reissuance of a non-expiring placard or how to ensure that our system is updated to administer this program for the individuals intended to be served should this proposed bill be enacted into law.



### **COMMITTEE REPORT DIGEST**

#### **I. OVERVIEW**

Bill No. 65-36 (COR) was introduced on February 26, 2021 by Senators Amanda L. Shelton, Mary Camacho Torres, Tina Rose Muña Barnes, Jose “Pedro” Terlaje and Sabina Flores Perez and was subsequently referred by the Committee on Rules to the Committee on Environment, Revenue and Taxation, Labor, Procurement, and Statistics, Research, and Planning on March 2, 2021.

The Committee on Environment, Revenue and Taxation, Labor, Procurement, and Statistics, Research, and Planning convened a virtual public hearing on Bill No. 65-36 (COR) on Thursday, April 15, 2021 at 9:00 A.M. via Zoom Video Conference Platform.

#### **Public Notice Requirements**

Virtual Public Hearing notices were disseminated via email to all Senators and all main media broadcasting outlets on April 8, 2021 and again on April 13, 2021, fulfilling the 5-Day Notice and 48 Hour Notice of the Open Government Law requirements respectively.

#### **II. SUMMARY OF TESTIMONY AND DISCUSSION**

The public hearing was Called-to-Order at 9:00 AM.

**Chairperson Perez:** The rules of conduct for this virtual hearing, the host will mute all participants until called upon by the Chair and virtual background should not be utilized during the hearing and participants face must be visible at all times. When called to speak, please remember to unmute yourself and that you are speaking into the microphone. Members of the committee wishing to speak may indicate their desire to do so, to the Chair through the in-app chat feature. The order of questioning will begin with the Chairperson followed by Senators. Each Senator will be allowed to pose questions to anybody on the panel. Individuals testifying shall first be recognized by the Chair before speaking and they shall state their name for record-keeping purposes. Questions and testimony shall be confined to the substance or nature of the agenda. Personal inference as to the character or the motive of any Senator, any individual testifying is not permitted. Any violations of this rule will result in the removal of from the host.

We're going to move on to the next item. It's Bill 65-36 (COR) sponsored by Senator Amanda Shelton, co-sponsored by Senators Mary Camacho Torres, Vice- Speaker, Tina Rose Muña Barnes, Senator Jose "Pedro" Terlaje and myself. It's an act to amend subsections (a)(4), (c)(1), (d)(2), and (d)(4), all of § 7120.1, Chapter 7, Title 16, Guam Code Annotated, relative to removing the date of expiration on removable windshield placards and extending the period of time for physician certification on temporary removable windshield placards. I'd like to allow the sponsor of this bill, Legislative Secretary, Amanda Shelton, for the introduction

**Senator Shelton:** *Håfa adai* again Madam Chair and thank you for hearing bill number 65-36 (COR) today and for this opportunity to speak on the bill. Our residents on island with permanent disabilities should not have to trek to the Department of Revenue and Taxation and wait in line to renew their accessibility placards. Bill No. 65 will remove the expiration date entirely on placards for those with permanent disabilities. For those who are listening and maybe in our community who are familiar, the permanent placards are the placards that are blue that we see in the windshield of the cars and the temporary placards that we're speaking about are the red placards. The bill also extends the upper limit of the placard's validity of temporary disabilities from 6 months to 12 months and the bill retains that disability of any kind must be certified by a physician. Individuals with disabilities may have a physical or mental impairment that restricts their activities of daily living requiring bi-annual doctors' visits and subjecting these individuals to long lines and copious amounts of paperwork is unnecessary. Because of the pandemic, government agencies must abide by limited occupancy and capacity rules created to keep our community safe. The bill seeks not only to support a vulnerable population but to ease DRTs increasing workload and alleviate staff that is spread thin already. Providing physical accommodations for those with limitations is insufficient if we do not advocate for an accessible and reasonable application process from start to finish. This bill breaks down barriers for individuals with disabilities in our community and brings relief to this very stressful process. I want to thank you again, Madam Chair, for your co-sponsorship and for hearing this bill today, and to our colleagues who've also signed on to support this effort. Just a little bit of background for our colleagues over the course of the pandemic, I received a few calls from disabled individuals in our community who have these placard cards in their cars, and they use it, and they were very worried about having to go to the Department of Rev and Tax, maybe make an appointment, wait in a long line to get it renewed because of an expiration date when they know that they've been confirmed to have a disability that they will have for life, and worried about having to go to the doctors first to get the physician's recertification and then go back to Rev and Tax to go through this process. It seemed very easy for us to come to the Guam code and fix this. Just a commonsense measure to break down this barrier and make the process easier for our community. Again, thank you very much.

**Chairperson Perez:** Thank you, Legislative Secretary Shelton. We did reach out to DRT. They have submitted written testimony, I believe. We just don't, I don't have the copy in front of me right now. It also received the fiscal note waiver. It's per BBMR, the bill is administrative in nature, imposes no physical impact upon any of the funds of Government of Guam. At this time, we don't have anybody here to present oral testimony, but I would like to give perhaps my colleagues opportunities to ask any questions. Senator Telo Taitague, any questions?

**Senator Taitague:** Not really. I appreciate this legislation. You know my father, who has a placard as well, and he's 92 years old. This makes it a whole lot easier for him to not have to go down to

Rev and Tax which is very taxing. Actually, it's almost impossible nowadays with the line and they're playing catch up. The only thing is to find some kind... I think we need to find some kind of assistance for those who have a disability and help them. Even more so I was hoping that the Director of Rev and Tax would be here, because I'm getting calls myself in my office where they're trying to make an appointment to go in to renew certain, even their business license as well, driver's license and some of them still drive, even my dad. But we don't make him drive by the way. I really was hoping that the Director would be here to answer some questions on how to assist those, our *manåmko*, and those especially with disabilities and getting anything renewed at this point. But I stand in full support of this legislation. I've seen my father having to get it renewed year after end but appreciate the legislation from the author, thank you so much.

**Chairperson Perez:** Thank you, Senator Taitague. Senator Mary Torres if you have any comments.

**Senator Torres:** No questions, I just want to thank the main sponsor for inviting me to co-sponsor. I think that whenever we can eliminate barriers for our *manåmko*, it's always a good thing to do. Thank you for including me in this legislation as a sponsor.

**Chairperson Perez:** Thank you, Senator Torres. Senator Brown, do you have any comments?

**Senator Brown:** Thank you very much, Madam Chair. No, I really don't, but I think it's a wonderful idea. I mean anything we can do to still facilitate, making sure that those that definitely need the designation for persons with disabilities to be able to go where they need to go, and be able to park where they need to park is a very good thing so I'm certainly very supportive of the legislation. Thank you for the opportunity to comment.

**Chairperson Perez:** Thank you, Senator Brown. Senator Moylan, do you have any comments?

**Senator Moylan:** No, thank you.

**Chairperson Perez:** Thank you, Senator Moylan. So, thank you to the Legislative Secretary for allowing me to be a co-sponsor as well. I know how difficult it is for the public to access the resources of DRT and especially those with disabilities. I think that it makes it even more difficult so anything that we can do to reduce the barriers to gaining access, equal access, I am in full support. So, at this time I would like to allow Legislative Secretary for closing remarks.

**Senator Shelton:** Thank you very much, Madam Chair. I know there was some discussion with DRT when we were getting ready to introduce the bill that there may be a problem if the placard was deteriorating even without an expiration date. We want to make sure that whoever is monitoring the disabled parking slots, that they're able to still see it's not breaking into pieces, and there may be a need down the line for them to be replaced or maybe laminated or kept in some kind of plastic protective equipment so that they last an even longer time than the three years that they're meant to last right now. Those are things that maybe we can continue discussing with DRT or it's addressed in their testimony. I'm not sure, we haven't seen it yet, but I do appreciate that they've been able to discuss this with us and help us move it forward, and to all of our colleagues



here today, thank you very much for your support and helping us to continue supporting individuals in our community who need a little extra assistance through this measure. I really appreciate it.

**Chairperson Perez:** Thank you, Legislative Secretary Shelton. So being that there are no more testimonies or comments at this time, Bill No. 65-36 (COR) is now duly heard.

Chairperson Perez adjourned the public hearing for Bill No. 65-36 (COR) at 12:05 p.m.

Additionally, this will eliminate the renewal process at DMV, saving time and money for all concerned.
