I. OVERVIEW

Bill No. 86-36 (COR) was introduced on March 17, 2021 by Senator Sabina Flores Perez and was subsequently referred by the Committee on Rules to the Committee on Public Accountability, Human Resources, Guam Buildup, Hagåtña Revitalization, Regional Affairs, Public Libraries, Telecommunications, and Technology on March 19, 2021.

The Committee on Public Accountability, Human Resources, Guam Buildup, Hagåtña Revitalization, Regional Affairs, Public Libraries, Telecommunications, and Technology convened a public hearing on Tuesday, April 6, 2021 at 9:00 AM in the Public Hearing Room of the Guam Congress Building.

II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was called-to-order at **9:05 A.M.**

Chairperson Tina Rose Muna Barnes: Next on the agenda item, colleagues, we have Bill No. 86-36 (COR) as introduced by Senator Sabina Flores Perez: “An Act to amend section 51A106(a)(2) and to add a new section 518106(a)(3) both of Chapter 51A, Title 10, Guam Code Annotated. Relative to expanding the qualification requirements for the Guam Solid Waste Authority General Manager's Position.”

I want to note to my colleagues and to the listening audience we do have Mr. Andrew Gayle. I believe the Chair was unable to join us physically, but he is here with us via Zoom. He is in the waiting room right now and thank you for taking the time to join us Mr. Gayle. I will allow the author or the sponsor to make her opening statement and then Mr. Gayle we will proceed with you. So if we can go ahead and do that I will allow Senator Perez at this time for her opening statement and then I'll ask audio to bring Mr. Gayle in. Senator?

Senator Sabina Perez: Thank you, Madam Chair, for this opportunity and for hosting this public hearing today. Bill 86-36 sponsored by myself Senator Sabina Flores Perez aims to create a larger pool of qualified candidates in order to find succeeding general managers for the Guam Solid Waste Authority. Bill 86-36 was developed at the request of the Guam Solid Waste Authority Board. Since August 2020, the Board of Directors has been searching for a General Manager; however, within those eight months Guam Solid Waste has received several interested applicants for the position but with educational qualifications that are not specifically listed with the current statute.

The current statute states that the General Manager must meet two criteria: a combined minimum of six years of documented experience successfully managing a solid waste management system of similar size as Guam Solid Waste System, and two, the graduation from accredited institution of higher education with a bachelor's degree in Business Management, Engineering Management, Engineering Technology, or Civil Engineering. Bill 86-36 proposes to expand the educational requirement to Environmental Science, Environmental Engineering, or a closely related field or discipline. Additionally, specialized training in waste management could also be considered to support the determination of necessary educational expertise in combination with a prerequisite management experience of a minimum of six years.

The selection of the current qualified General Manager by Guam Solid Waste Board was a key component to ending the decades-long federal receivership, and I wanted to thank the highly qualified Guam Solid Waste Board members for continuing their service and strengthening Guam Solid Waste as a local entity and for initiating a solution and

expanding the pool of qualified applicants. I look forward to the discussion and advanced support from my colleagues for this important piece of legislation. *Si Yu'os ma'ase.*

Chairperson Tina Rose Muna Barnes: You're very welcome, Senator Perez. At this time, to the audio team, can we please get Mr. Gayle on. Good morning Mr. Gayle, Can you hear me?

Chairman Andrew Gayle, Guam Solid Waste Board: Good morning, Senator Barnes. Yes I can hear you fine.

Chairperson Tina Rose Muna Barnes: Yes please proceed. State your name for the record if you support the measure or not and then you can proceed with your testimony. *Saina Ma'ase.*

Chairman Andrew Gayle, Guam Solid Waste Board: Good morning Senators. My name is uh Andrew Gayle. I am currently the chairman of the Guam Solid Waste Board of Authority, excuse me, Guam Solid Waste Authority Board of Directors. I'd like to thank Senator Perez for working with the GSWA Board and management on this bill. GSWA has been very lucky to have our current General Manager, Larry Gast on board due to his wealth and experience in the industry. However, Mr. Gast would like to retire and so we find ourselves searching for another qualified GM to take the helm of Guam Solid Waste Authority, lead us out of the very last piece of receivership and continue to meet our local and federal requirements for municipal solid waste.

As Senator Perez mentioned, the current statutory requirements for the GM are very specific in both education and past experience. We have advertised this General Manager position locally as well as on the Solid Waste Association of North America also known as SWANA. Their website SWANA is a national trade organization dedicated to solid waste management. Now while we have received several seemingly qualified applicants for this position, none of the applicants have met the education requirements well they have all met the uh experience requirements. The current education, again, the current education requirements call for very specific degrees. And so we are simply requesting for a wider consideration of undergraduate degrees as well as some flexibility regarding the degree when considering potential GM candidates.

If this law were to pass, there are at least three GM candidates who are still interested in the job and who would meet the revised education requirements and existing experience requirements, Furthermore, we probably get more applicants because several applicants picked up an application but actually didn't turn in an application uh which we think was due to the education requirements. The board of the Guam Solid Waste Authority is in full support of this bill and we humbly ask for your support as we try to ensure that we can continue to meet our federal and local regulatory requirements. Thank you very much.

Chairperson Tina Rose Muna Barnes: Thank you very much Mr. Chair. I will note for the record that BBMR has submitted their Fiscal Note, and it notes that “this bill is administrative in nature and has no fiscal impact.” So at this time, I will ask Senator Perez, do you have any questions for Mr. Gayle?

Senator Sabina Perez: No questions, thank you.

Chairperson Tina Rose Muna Barnes: Okay. Minority Leader, Senator Duenas?

Senator Chris Duenas: *Si Yu'os ma'åse*, Madam Chair, Mr. Gayle, thank you for your testimony. Coming it as being fully supported from GSWA and the board, I guess the only one question I would ask is, are there other jurisdictions that have less of a requirement than what we do and are those individuals who would otherwise qualify and are interested in the job if this bill were to pass? Have they worked in other municipal Solid Waste Organizations where that's the experience that they would bring as well?

Chairman Andrew Gayle, Guam Solid Waste Board: Yeah now like Senator Perez had mentioned that there are two qualifications. There are two specific qualifications that the current statute requires and one is a level of experience in a municipality of similar size to Guam. And the current three applicants that we have actually talked to all meet those specific requirements. And so to answer your question, they do meet the experience requirements, but they just don't meet the very specific education requirements. The ironic thing is one of our applicants, you know, has a degree in Natural Resources which has a specific, you know, and it's in specific study in Solid Waste Management; but yet that doesn't meet the the current statutory requirements for the General Manager of GSWA so that's why we're just looking for a little bit of flexibility.

Another, you know, another applicant, you know, he's been in the industry for 30 more than 30 years, but his undergraduate degree was in Biology which is, you know, as a science, but it's not specifically meet the statutory requirements. And, you know, he has a similar breadth of knowledge that our current General Manager has in both opening landfills and closing landfills which really what really Larry Gast, Mr. Gast really helped out the, you know, Guam Solid Waste Authority with that level of experience, you know, both the opening and closing of landfills because that's what we're working on right now.

And so these individuals were all working in other jurisdictions in solid waste management and so they have risen to their level of management with the current education that they have.

Senator Chris Duenas: That's excellent to know. Thank you very much and I just wanted to let you know, Andy and your team, I have full faith and confidence and having you know had your team brought this recommendation forward, and I know you're gonna look and try to get the best candidate. But if the legislation's prohibitive and obviously other jurisdictions have no issues with this and knowing that one of the applicants is in,

you know, studies in Environmental Science i think that's the guy we more than likely need. So it sounds like you've got a great pool to select from and this looks like very important legislation and I look forward to supporting it. Thanks Andy.

Chairman Andrew Gayle, Guam Solid Waste Board: Thank you, Senator.

Chairperson Tina Rose Muna Barnes: Thank you, Senator Duenas. Senator Blas? Senator Telo?

Senator Telo Taitague: *Si Yu'os ma'åse*, Madam Chair, for the opportunity to speak and thank you, Mr. Gayle for being here and, of course, working with the Oversight Chair with regards to this legislation. We're all familiar with Mr. Gast wanting to retire. So if this legislation were to pass, how soon would this position be filled?

Chairman Andrew Gayle, Guam Solid Waste Board: Well, we'd have to go back to the candidates and what I'd recommend is we go back to the candidates and say we can now fully consider you as a qualified applicant and continue with our interviewing process. All we've had is that we've had initial discussions. What I find very fortunate is we have three right now we have three qualified ... if this legislation passed, we would have three qualified candidates who've all expressed interest in coming to Guam. I would recommend that we would, you know, repost our SWANA advertisement, you know, our advertisement both locally and in SWANA and see if we have any more applicants who might meet these new education requirements and to get as large a pool as possible.

After that then I think it'll still take at least, you know, a few months in order for us to vet a candidate, for that candidate to, you know, agree to the position, to negotiate, you know, to negotiate a salary, and then for them to relocate to Guam. All of these candidates at least the current candidates are located in, you know, they're all located in North America. Two are located in the US and one is located in Canada. And so there would be some time for that. In the meantime, Mr. Gast has agreed to stay on as the General Manager. He is working remotely for the most part, but he has agreed to stay on and then help train the General Manager when he comes on board in the new report.

Senator Telo Taitague: Thank you for that thorough answer because it answered a lot of the other questions about the applicants and uh who's available so I appreciate that. Who determines the Deputy General Manager? Who makes that decision?

Chairman Andrew Gayle, Guam Solid Waste Board: So that was determined by the General Manager. We opened up there was a decision made at the board level since in order for us to get through this specific issue and the actual, the enabling statute of the Guam Solid Waste Authority allows for the position of ... they call it Assistant General Manager. I believe is the actual terminology and the statute for technical and operations. And so that was the position opened up at the behest of the board. And the General Manager decided on that position because that person reports to the General Manager.

Senator Telo Taitague: Okay but it's approved by the board then, correct?

Chairman Andrew Gayle, Guam Solid Waste Board: It was.

Senator Telo Taitague: Okay so my last question, Mr. Gayle, how many other individuals have been able to fill this position beside Mr. Gast?

Chairman Andrew Gayle, Guam Solid Waste Board: I've been able to... I'm sorry.

Senator Telo Taitague: With the qualifications that are required by statute right now, how many other individuals was able to fill this position?

Chairman Andrew Gayle, Guam Solid Waste Board: I mean before Mr. Gast or after Mr. Gast?

Senator Telo Taitague: Yes, before.

Chairman Andrew Gayle, Guam Solid Waste Board: Well we had one individual who was able to fill this position before Mr. Gast. You know, on paper he had the qualifications; however, I think, you know, and we had ... that individual resigned for various reasons before we ended the receivership. In retrospect, I think Mr. Gast ended up working out better for us because Mr. Gast had a much wider experience in terms of opening and closing landfills than the previous applicant ... then the previous General Manager.

Senator Telo Taitague: Okay, okay well thank you so much for that. I appreciate your time. Thank you miss ... Madam Chair.

Chairperson Tina Rose Muna Barnes: Thank you Senator Taitague. Senator, I do apologize, before I go to Senator Brown. I understand Senator Moylan has joined us. Thank you very much Senator Jim for joining us this morning. Senator Brown you're recognized.

Senator Joanne Brown: Thank you very much, Madam Chair. I did want to ask Chairman Gayle just to get an idea just as it relates to the hiring of a new General Manager. Could you just update us on what the current status is with regards to Guam Solid Waste and the receivership in the federal court has that process been concluded? Or is there anything remaining with regards to that relationship for the Guam Solid Waste to be totally independent from oversight from the federal government with regards to its operations and its mandates?

Chairman Andrew Gayle, Guam Solid Waste Board: Sure, sure. Thank you, Senator, that's an excellent question and there's a lot of confusion about that right now. We are the Guam Solid Waste Authority is still in partial receivership under the auspices of the local district court. What that means is last year or was it in 2019? It was 2019 when the district

local district court gave operational relinquished operational control of the Guam Solid Waste Authority which is the daily you know daily operations of collecting the waste etc. to the Guam Solid Waste Authority Board and its management team.

The one piece that was remains under control of the receivership is the closure that is the final closure plan for the Ordot dump so that's what is known as the post-closure plan. So that still remains under the auspices of the receivership. GBB Gerschmann Brickner Brandon still has control of that aspect and has control of a certain amount of monies dedicated for that particular aspect. That was supposed to be completed. Now that end of the receivership would have happened when the final permit would be issued for the operation of that post-closure plan. That final permit has been worked on and has been delayed due to COVID and other reasons has been delayed over a year. It was supposed to happen mid 2020. But it is now you know mid 2021 and we don't have a final timeline for when that plan and that permit will be ready for review. That's really driven by the US EPA and that is where apparently is where the delay is coming from.

So while we do have ... we are still working on the new cell that lads of land... through that falls under GSWA the new seller lads and landfill, the daily operations of the residential collections, the hauler only transfer station, all the recycling efforts that we do those are all under the control of the Guam Solid Waste Authority with our budget. It's that last piece of the Ordot post-closure plan that it still remains under the auspices of the receivership.

Senator Joanne Brown: Thank you. I appreciate that information and the update. I'm just asking and inquiring so certainly at least with regards to the hiring of a General Manager that would fall under the responsibility of our current solid waste board. And certainly, I have no objection to amending the requirements. I mean their capabilities as an administrator are, you know, their valued capabilities, and certainly, we want someone who has a background. I think these respective positions and educational requirements and experience will still meet that. And it doesn't prevent the Guam Solid Waste Authority, certainly from hiring specific engineering skills if that's needed and other environmental experts that they would need to address the continued management expansion, and obviously the eventual closure of our current landfill that we have at Layon.

So I appreciate the input from the Chairman with regards to the current status and the update of the oversight of the federal court and the receivership with regards to the Guam Solid Waste Authority. And Madam Chair, I certainly support this legislation, have no problem with it. We want to get a qualified individual that can fill this position and continue on the mandates of the solid waste and hopefully moving into the future. We don't get to where we were with regards to these issues existing for so long that we end up having federal control coming in to help manage any aspect of our government. So

with that, thank you very much, Madam Chair, for the opportunity to inquire a question and comment on this bill. Thank you.

Chairperson Tina Rose Muna Barnes: Thank you Senator Brown. Senator Jim Moylan, do you have any comments or questions for Mr. Gayle?

Senator James Moylan: Thank you, Madam Chair. I, too, support the bill. I think it's a good idea. We're expanding those that can be qualified for our position so we can get a better choice and selection of fulfilling our needs on the island. One thing that the next person taking the wheel will also be concerned about. I'd like to ask you, Mr. Gayle, also on your opinion or just to give further insight regarding the pandemic situation and our collections, right? The amount of money that we're collecting.

I did have constituents call my office and they were concerned about not being able to pay their tipping fees because of their loss of employment due to the pandemic. And if you can just expand or let us know what are the arrangements for these types of situations or if residential trash bins are being picked up uh due to lack of payment from the residents there. And if it's for other reasons maybe board if it's specifically for the pandemic what are we doing to work with the customers so we can continue the class trash pickup and as we come out of the pandemic and people get back to work. Thank you.

Chairman Andrew Gayle, Guam Solid Waste Board: Well, Senator Moylan, you know, the Guam Solid Waste Authority has specific rules regarding its current service. One of those rules is, if you are delinquent in your payment of more than I forget. I can't remember if it's 60 days or 90 days to the truth it's, you know, it's a management operational thing. But if you're delinquent more than x number of days then you're subject to having your trash bin collected and you won't be able to resume that residential trash service until, you know, you clear your account. And actually pay, I think you pay a fee to have your bin restored. I mean we are subject to the same, you know, bills and you know, expenses that any other business would be. And we have seen our impact to our revenue levels as well, and we're forced to you know to be to look at cutting costs and looking at other areas for our, you know, to make up for specific revenue loss. But you know that specific behavior is in our, you know, existing rules and regulations, you know. We do offer, you know, residential transfer stations through ... there are three residential transfer stations on the island that residents can pay a one-time fee and deposit their trash that could end up being more economical for certain people than the monthly residential trash pickup. But we have resumed that service. I mean that that policy of collecting bins for people who are delinquent in their payments.

Senator James Moylan: Okay, Mr. Gayle, so if I understand correctly then we're... it's a status quo and just if you're not paying your bills within the guidelines, nothing. There's no exception for the pandemic situation and loss of employment due to the pandemic. So

we're basically following our standard procedures versus like the utility agencies they're able to make a payment plan or something to work with the customers. But we're saying the solid waste for residential, we're not making any exceptions for it at this time. Is that correct?

Chairman Andrew Gayle, Guam Solid Waste Board: We suspended delinquencies for about three or four months last year during the pandemic, but then we resumed them at the end of, near the end of 2020. I mean, we're not a you know we're not a very large agency. We're not as large as GWA or GPA, you know. We're, you know, a 17-18 million dollar agency with, you know, 60 employees. We don't have the luxury of being able to, you know, come up with, you know, not collect from our subscribers, and we have to operate our businesses as, you know, to remain solvent and be, you know, to meet our regulatory requirements with both federal and local. That's something we're extremely cognizant of.

Senator James Moylan: Okay, I appreciate that that's clear and then on for our collection site the greatest revenue comes from the commercial uh trash pickup. And what is your losses if you can give a summary of that on the commercial side since residential is such a small part of the total revenue for Guam Solid Waste?

Chairman Andrew Gayle, Guam Solid Waste Board: Well it's not a small part. It's about a 60/40 split. Sixty percent (60%) comes from commercial revenue. About forty percent (40%) from residential revenue. But you know, we have seen an increase in residential tonnage right? You know, we don't charge our residents based on the amount of trash; we just charge them on the amount of the number of bins. But we've seen the increase in the tonnage, you know, that people were cleaning out their houses during the pandemic and there's an increase in household trash while there's a reduction in commercial revenue. We saw a reduction in commercial revenue of, I don't know, I think over over the course of the year maybe 15-20 percent in reduction in commercial revenue that's impacted our overall revenue by about 10 percent.

Senator James Moylan: I think, thank you, Mr. Gayle. It's a really good and clear explanation. I appreciate that. Thank you, Madam Chair.

Chairperson Tina Rose Muna Barnes: Thank you, Senator Moylan. And I want to take the time to thank Mr. Gayle the chairman of the board for Guam Solid Waste Authority for answering several ... this is not an oversight but for answering, taking the time for answering some of the questions. I will allow the author of the bill, Senator Perez, to close at this time.

Senator Sabina Perez: Thank you, Madam Chair. And I just wanted to thank my colleagues for their comments, questions, and most of all their support for this bill. And just to kind of answer some of the questions when looking at the qualifications and educational qualifications, there were some jurisdictions that even allowed for a high

school education diploma so, you know, we didn't want to go that far and really in relaxing the educational requirements. We felt that there has to be a definite hard science background in managing this very important utility and the language that we put in was very closely related to other utilities that we have here on Guam. So I guess in closing, I just look forward to working with the Chair and hoping to move this bill forward as expeditiously for our April session. *Si Yu'os ma'åse.*

Chairperson Tina Rose Muna Barnes: Thank you, Senator Perez. Duly noted. With that, we will call Bill No. 86-36 (COR) publicly heard.

The public hearing was adjourned at 10:54 a.m.

III. FINDINGS AND RECOMMENDATIONS

The Committee on Public Accountability, Human Resources, Guam Buildup, Hagåtña Revitalization, Regional Affairs, Public Libraries, Telecommunications, and Technology finds that Bill No. 86-36 (COR) received favorable testimony during the public hearing.

Bill No. 86-36 (COR) received support from the Guam Solid Waste Authority, Board of Directors Chairman Andrew Gayle. He noted to the panel that many applicants who have applied for the position of General Manager have met the experience qualifications and requirements but do not meet the educational requirements, thus expanding the educational field of requirements would be beneficial and ultimately widen their selection for a candidate to fill the position of General Manager.

Section 2. § 51A106(a) of Chapter 51A, Title 10, Guam Code Annotated, is hereby *amended* to read:

“(2) graduation from an accredited institution of higher education with a Bachelors degree in Business Management, Engineering Management, Engineering Technology, ~~or~~ Civil Engineering, Environmental Science, Environmental Engineering, or a closely related field or discipline.

1 (A) If in the best interest of the Authority, the Board may
2 consider other related industry training and certification.”

3 **Section 4. Severability.** If any provision of this Act or its application to
4 any person or circumstance is found to be invalid or contrary to law, such invalidity
5 *shall not* affect other provisions or applications of this Act that can be given effect
6 without the invalid provision or application, and to this end the provisions of this
7 Act are severable.
