Bill No. 95-36 (LS) was introduced on March 25, 2021 by Senator Amanda L. Shelton, Senator Jose "Pedo" Terlaje, Senator Clynton E. Ridgell, Vice Speaker Tina Rose Muña Barnes, Senator Telena Cruz Nelson, Senator V. Anthony Ada, Senator James C. Moylan, Senator Frank Blas, Jr., Senator Christopher M. Dueñas. The Bill was referred by the Committee on Rules to the Committee on Air Transportation, Parks, Tourism, Higher Education and the Advancement of Women, Youth and Senior Citizens ("Committee") on March 26, 2021.

The Committee convened a Virtual Public Hearing on Bill No. 95-36 (LS) on Friday, July 16, 2021 at 1:00 p.m. via Zoom Conference platform.

II. SUMMARY OF TESTIMONY AND DISCUSSION

The Virtual Public Hearing was called-to-order at **1:00 p.m.** Bill No. 95-36 (LS) was among the items discussed during the Virtual Public Hearing.

Chairperson Amanda L. Shelton:

We will now continue with the final item on our agenda: Bill No. 95-36 (LS) introduced by Senators Amanda L. Shelton, Jose "Pedo" Terlaje, Clynton E. Ridgell, Tina Rose Muña Barnes, Telena Cruz Nelson, V. Anthony Ada, James C. Moylan, Frank Blas Jr. and Christopher M. Dueñas - AN ACT TO AMEND § 77104.1 OF ARTICLE 1, CHAPTER 77, TITLE 21, GUAM CODE ANNOTATED, RELATIVE TO INCLUDING ALL PEACE OFFICERS IN THE ENFORCEMENT OF ALCOHOL FREE ZONE. Bill No. 95-36 (LS) seeks to allow any peace officer, as defined under Guam's Peace Officer Standards and Training Commission law, to enforce the Alcohol-Free Zones (AFZ) provisions and issue citations and fines to violators. Our parks are an essential part of our island and our culture. As such, they are integral to our community's well-being. They provide a tangible reflection of the quality of life in our community, most especially during this pandemic. Our parks offer safe outdoor recreational places for our families, social groups, and individuals of all ages and economic statuses. Over the last year, we have seen an increase in the use of our public parks as families found solace and enjoyment in nature during these difficult times. However, due to the rise in activity, our community requires more human resources to monitor these areas and provide citations, if needed. As the law currently stands, officers from the Department of Parks and Recreation Park Patrol Division and the Guam Police Department are responsible for enforcing the Alcohol-Free Zones in the parks. And we've already seen this collaboration that Bill 95 seeks to strengthen among our public safety partners. During the pandemic, different law enforcement agencies collaborated to fill the gaps in our public safety force, and this measure seeks to solidify those partnerships. Under Bill 95, Alcohol Free Zones can be enforced by trained peace officers from the following agencies: Department of Parks and Recreation; Guam Police Department; Guam Fire Department; Guam Airport Police; Guam Port Authority Police; Department of Corrections; Department of Youth Affairs; Department of Agriculture; Guam Customs and Quarantine Agency; Office of the Attorney General; and Guam Marshals and Judiciary Probation Officers. I want to thank my colleagues who have signed on as co-sponsors of Bill 95, Senator Terlaje, Senator Ridgell, Vice Speaker Muña Barnes, Senator Nelson, Senator Ada, Senator Moylan, Senator Blas, and Senator Dueñas, as well as our partners at DPR and their Park Patrol Division, who continue to do their best to keep our parks



safe and clean for our community to enjoy. As the island returns to normalcy, the maintenance and safety of our public parks lie at the heart of our recovery efforts. Bill 95 will augment the workforce capable of enforcing our rules and will dramatically increase public safety to keep our parks intact. It's this kind of collaboration that we're going to empower our law enforcement agencies to be able to have and to solidify these partnerships that will help keep our parks and our public spaces a safer place. I look forward to the discussion today and I welcome Officer Pedro Lizama from the Department of Parks and Recreation, Park Patrol Division, to give testimony now.

Officer Pedro Lizama, Department of Parks and Recreation:

Senators, Speaker Terlaje, my name is Officer Pedro Lizama with the Department of Parks and Recreation. I'm here on behalf of the Department of Parks and Recreation and Director Roque Alcantara to give testimony in support of Bill 95. I'd like to thank Senator Shelton for bringing forward this bill. This bill will go a long way in assisting us with the enforcement of the alcohol-free zones. Currently, as we are all aware, there are only two park patrol officers for the patrol of all the island's parks, so that leaves huge gaps in our patrol, and our response for various issues, not just alcohol-free zones. So this bill will help us in plugging in those holes in our manpower for the enforcement of alcohol-free zones. That's all the testimony I have to give, and I'd like to thank all the co-sponsors of the bill for coming out in support of Senator Shelton.

Chairperson Shelton:

Thank you very much, Officer Lizama. I'd just like to speak a little bit about how this bill came to be. After meeting with the Department of Parks and Recreation, and also meeting with the Department of Agriculture conservation officers who shared that they were all part of this task force during the time of the pandemic and helping to enforce laws and throughout that time, really supporting each other and leaning on each other throughout the pandemic, and they realize that many of these law enforcement agencies also patrol. They stopped by the parks or they're in the area, or patrolling the seashore, and they would see violations at the parks, but they were not authorized under the law to to cite anyone or to enforce the law there, and so we came up with this with this policy proposal here today, we look forward to being able to give our law enforcement officers, especially the Department of Parks and Recreation, our park patrol division, a little more support. I know we've been talking about it in many different ways. The reservist program, this is just another added layer to help our parks be a safer place. So colleagues, if you have any questions for Officer Lizama, Speaker Terlaje, if you'd like to begin.



Speaker Therese M. Terlaje:

Thank you so much Madam Chair and Officer Lizama. Thank you for your testimony. I do have a couple questions, if you don't mind. I totally support this bill, and when you look at it, it makes us wonder why we didn't do this earlier and why did we limit it in the first place, because it makes so much sense. I think it's a great bill, and I do want to help you officers as much as possible. That's my question. We continue to hear this talk about, "It's not my jurisdiction, it's not my jurisdiction, it's their jurisdiction..." and we're relying on two officers to take care of this entire island. Do you think we need to do this in more areas where we share jurisdictions? Do you think you need to be specially trained conservation officers in order to enforce what happens, in the marine preserve for example, I was there. I'm not sure who gets to enforce those right now, but I was there one day and some motor vehicle comes into the marine preserve at Ypao, and the lifeguards couldn't do anything about it except tell them, "You better turn around or we're gonna call the police, and something's going to happen to you...." but they couldn't stop them, and then they had safety officers there from GVB hired, private contracted safety officers, but they didn't seem to have any jurisdiction over it, and so I guess I just wanted to hear your thoughts on it. I want to know how far we can go with this type of thing, and what's your recommendation?

Officer Lizama:

Thank you, Speaker, for bringing this issue up. As far as speaking to outside of the bill and what the bill proposes, I think those are ideas that we have to engage the professionals of their jurisdictions on to the extent of how much outside law enforcement can come and help them, as to this bill I can speak to my personal experience, and as Senator Amanda has mentioned, we did have a task force and during that task force, we encountered that issue where we were given the additional duties of enforcing the alcohol-free zones and enforcing the drinking violations occurring there, so the conservation officers brought up a good good point. When we reviewed the the statute, it did not include them in the enforcement, and the authority powers there so the only ones that were allowed to do the enforcement and issue the citations were park patrol and GPD, so we had this task force, yet we're handicapped because some of the members couldn't do what the mission was calling for. Thank you.

Speaker Terlaje:

Yes thank you very much, Officer Lizama, what is your jurisdiction right now? Do you have exclusive jurisdiction for violations of marine preserve rules?

Officer Lizama:

Well in specific to the marine preserves, that would fall under the jurisdiction of the Department of Agriculture's conservation officers section. That's basically their job.



Speaker Terlaje:

What happens if you are the one who encounters a violation there? You have to call them and wait for them to show up?

Officer Lizama:

Not necessarily, for example there are certain areas where we do have concurrent jurisdiction. We do have parks in preserves for example there'd be fisheye park that's which we also know as tokungian and there's also e pal beach park and the topping beach as well so those are located in the tuman preserve so we do observe somebody violating the preserved laws or the rules and regs if we're not certain if it's a violation then of course we'll contact department of agriculture and get guidance from them but if it is happening while we're there then of course we will act, whether we take an arrest or pull a guy over, or whether we give counseling. That's our discussion.

Speaker Terlaje:

Thank you very much officer. Thank you Madam Chair.

Chairperson Shelton:

Thank you very much. Senator Nelson, any questions?

Senator Telena Cruz Nelson:

Thank you very much, Madam Chair. I just want to say that I support this bill, and I thank all of the officers at DPR for the enormous amount of work that they do and the great job that they have been doing. Thank you very much.

Chairperson Shelton:

Thank you, Senator Nelson. Senator Ada?

Senator V. Anthony Ada:

Thank you, Madam Chair. Thank you for introducing this legislation and asking me to be a co-sponsor. Officer Lizama, I know that the task is just tremendous. When you got so many parks to look over from north to south, and perhaps Madam Chair, maybe not just the alcohol-free zones, but perhaps looking into joint jurisdictions on enforcement of parks rules and regulations. For example, I see the park rangers out there when it comes to being at Tiguac cemetery and Veterans cemetery, and they're just so short-handed that if we're able to get other law enforcement agencies to assist them then I think looking at that as well, not just alcohol enforcement but let's see what we can do to continue to assist our law enforcement officers to help one another by enforcing the rules and regulations and knowing that each other can can respond to something that if the park rangers are not there then GPD or even the DYA folks



that are in the area, they can just radio and say we need assistance here, but just something to to keep an eye on, and let's let's look how we can think outside the box to help our law enforcement agencies, but thank you Madam Chair for the opportunity again. Thank you Officer Lizama.

Chairperson Shelton:

Thank you, Senator Ada. There is certainly a lot of room for collaboration and support to give each other throughout the law enforcement community so I appreciate that. Senator Taitague?

Senator Telo T. Taitague:

Thank you, Madam Chair. My internet is not very very good so I hope I can get through. That's why I've been bouncing from one room to another. Can you hear me? Senator Ada made such a great point not just limiting to just places that you do now but alcohol-free zones and thank you first Officer Lizama. I've spoken to you many times on other occasions on certain questions that I had, and you've been very good at not only answering him but if you didn't have the answer you went and you looked for it and went through the books and the code for me. I greatly appreciate the continued collaboration we have with each other in my office and yours as well but are there areas that the Senator was talking about? Are there any beach areas that are considered very popular where people go that are not considered a park?

Officer Lizama:

There are many beach areas that are popular that are not within the Department of Parks and Recreation, park inventory for example, which is off the top of my head. I can say Jimmy D's area, that beach area is not part of our park area... What else... Fujita road, are you familiar with that beach area there? That's not a park area, very much majority of the shoreline of Tumon with the exception of Ypao and Matapang, those are not considered park areas as well.

Senator Taitague:

Are they considered still under the jurisdiction of the Government of Guam?

Officer Lizama:

Yes, there's a gray area there because I think they're covered under the territorial seashore protection act. I mean we can get into that, but it's gonna take a while. It's basically all that the beach area that we had just mentioned is covered under the territorial seashore protection act.

Senator Taitague:



I remember we talked about that actually because there was one such beach that actually has a trash can that's made of cement, so it's obvious it looks like it almost looks like it's a park and it's a little bit further down from and it looks like it's a park area because of this cement trash bin that's there, and then you sometimes the LMS that is contracted with the Guam Visitors Bureau that comes and picks up the trash. In that situation, do you have the jurisdiction to go into that area and actually, if someone is doing anything, violating any kind of regulations, do you have the jurisdiction to go in there too as well?

Officer Lizama:

No, we do not. I know the area you're speaking about, and we have many areas like that throughout the island. Like I said, they look like part of the beach but are under the territorial seashore protection act. They fall outside of the beach area too.

Senator Taitague:

So if there's something happening in that area, then our best bet is to just call GPD instead of the rangers like you guys?

Officer Lizama:

Right, that would fall under the jurisdiction of the Guam Police Department, which they have your jurisdiction over all the property of Guam.

Senator Taitague:

Thank you for that and thank you for all your hard work. There's still just two of you right now that are overseeing the parks or do we have that third person?

Officer Lizama:

That's correct Senator, there's still just two of us.

Senator Taitague:

Hopefully we can work on something. I know our oversight chair is doing her best diligently to try and get somebody in the position. I know she has been working very hard on it, and I'd like to do anything I can to, Madam Chair, if there's anything I can do to assist to to help in that area but it might be something else we might want to look at because there are some places that look like parks but they're not, and to give them the ability to to go in there and put out citations or assist when the public needs it, especially in the safety issue so thank you Madam Chair for the opportunity and looking forward to being a co-sponsor on this bill too as well.

Chairperson Shelton:



Absolutely, thank you so much Senator Taitague. Thank you, and now we'll move on to Senator Brown.

Senator Joanne M. Brown:

Thank you very much, Madam Chair. I don't have any questions, just thanking Officer Lizama again for his participation considering the workload he and his fellow park ranger have been trying to do their due diligence, and their work at our numerous parts of which they are incredibly understaffed. I'm hopeful that in our new budget deliberations, while certainly conservative with a budget, I definitely would like to see more support provided to our officers and our park rangers because it's very difficult for just the two of them to do the tremendous job that we've tasked them to do. Other than that, I certainly will be supportive of multiplying the enforcement capability with the passage of this bill and hopefully also be considered as a co-sponsor with that. Madam Chair, thank you very much for the opportunity to comment.

Chairperson Shelton:

Absolutely. Senator Brown, thank you very much. Officer Lizama, before we conclude, I just wanted to ask you if you can speak about the system you have for citations. Will it be easy enough for you and your law enforcement partners to have a shared system to cite people at the parks? Can you just speak to that a little bit?

Officer Lizama:

Yes, the current system that we have right now is basically... our citations are out of the court. They're issued to us from the court and the court handles all the processing for citations so just like you would for a traffic violation or litter citation, or any other court issued citation, that's how these things will be processed, and it's used by almost all the law enforcement agencies that I'm aware of.

Chairperson Shelton:

Great. That's good to know that we won't be tacking on any additional assignments to help us get all on the same page here to allow the other law enforcement agencies to do this so we already have the system in place. I appreciate that and of course your time here today your input to help us draft this bill and get this through and to all the partners at DPR and our other law enforcement agencies who we know are all ready willing to step up to help the Department of Parks and Recreation, our park patrol division keep our parks safe. Thank you very much and with that the committee has duly heard Bill No. 95-36, and we of course will continue to accept office. testimony here our You can email testimony officeofSenatorshelton@guamlegislature.org or deliver your handwritten testimony

III. FINDINGS AND RECOMMENDATIONS

The Committee finds that all those providing testimony to the Committee expressed favorable support of **Bill No. 95-36 (LS).** The Committee amended the Bill to reflect changes regarding format and style, as recommended by the Legal Bureau (see mark-up attached).

The Committee further finds that Bill 95 seeks to strengthen the partnership between Guam's law enforcement agencies and provides the available support to carry out the mandates of the Park Patrol Division of the Department of Parks and Recreation, which is short-staffed at only two (2) park patrol officers.

The Committee further finds that the expansion of authority to other peace officers will not disrupt the citation and fees system in place that is utilized by park patrol officers and all other law enforcement agencies.



Bureau of Budget & Management Research Comments on Bill No. 95-36 (LS)

Bill No. 95-36 proposes to amend § 77104.1 of Article 1, Chapter 77, Title 21, Guam Code Annotated to give jurisdiction to all peace officers, as defined in 17 GCA, § 51101(b), to issue citations to any person who possesses or consumes alcohol in an "Alcohol Free Zone" (AFZ) within the Guam Territorial Park system. Existing law authorizes only Territorial Park Patrol Officers and Guam Police Officers jurisdiction in these AFZs. The Bill expands this jurisdiction to all peace officers, to include officers from the Guam Police Department, Guam Airport Police, Guam Port Authority Police, Department of Corrections, Customs and Quarantine Agency, Department of Youth Affairs, Division of Aquatic and Wildlife Resources, Attorney General's Office, Unified Guam Judiciary, and the Guam Fire Department.

In accordance with § 77104.2 (d), all fines collected as a result of penalties imposed by § 77104.1 shall be deposited in the "Public Recreation Services Fund (PRSF)", which was created specifically for the Department of Parks and Recreation (DPR). Because the Bill proposes to increase the resources to issue citations, the fines associated with each additional violation would contribute to the overall deposits into the PRSF. However, absent additional information such as how many citations are issued in a given time period, how much of the fines are actually paid and what percentage of the fines contribute to the PRSF, a more accurate fiscal impact of this legislation cannot be determined at this time. Furthermore, the expansion of additional peace officers to issue citations in AFZs may affect each agencies' operational budgets should they assign officers to patrol and monitor these AFZs outside their regular areas of operation.
