The Bureau requests that Bill No. 37-36 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill 37-36 (COR) is an act to amend §4101(a)(1) of Article 1, and to add a new §4203.4 to Article 2, both of Chapter 4, Title 4, Guam Code Annotated (GCA), relative to the prohibition of employment in the Government of Guam for individuals convicted of official misconduct under the provisions of 9 GCA §49.90.

The proposed legislation intends to disqualify an individual for employment within the Government of Guam should such individual have been convicted of an offense under the provisions of 9 GCA §49.90 relative to official misconduct.

As such, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
