The Bureau requests that Bill No. 31-36 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill 31-36 (COR) is an act to add §4101.2 to Chapter 4 of Title 4, Guam Code Annotated relative to modernizing a process which would allow for the streamlining in the recruitment and hiring of law enforcement officers, to be known as "The Swift Appointment Modernization Act of 2021". The proposed legislation intends to facilitate such purpose by increasing the list of applicants made available to qualified law enforcement agencies, reducing the appeal period timeline, and allowing qualified law enforcement agencies a continuation of interviews.

As such, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
