The intent of Bill No. 206-36 (LS) is to require and appropriate funds for a public hearing of interim rules produced by the Department of Public Health and Social Services (DPIISS) in order to ensure transparency, permit public participation therein, and provide a method of making rules readily accessible to the public. Section 3 of the bill appropriates the sum of \$1,000 from the unexpended funds of the Office of Senator Mary Camacho Torres of *I Liheslaturan Guåhan* to DPHSS for the sole purpose of preparing, promulgating, and publishing rules and regulations pursuant to the Act.

DPHSS states that many of the services made available by the Department to the community of Guam are either free of charge or made available at a discounted rate. Per DPHSS, the Department will need to hire additional staff to handle the additional responsibilities of the proposed legislation. Staffing needs include one (1) Program Coordinator III (N-01 at Salary- S45,014 and Benefits 29.77%- \$13,400.67) and one (1) Social Worker III (N-01 at Salary- \$45,014 and Benefits 29.77%- \$13,400.67) for the purpose of licensing, regulating and monitoring compliance.
