The Bureau requests that Bill No. 210-36 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 210-36 (COR) is "AN ACT TO AMEND § 79606 OF ARTICLE 6 OF CHAPTER 79, TITLE 21, GUAM CODE ANNOTATED, RELATIVE TO INCREASING THE SIZE OF THE MEMORIAL'S FOUNDATION; AND TO APPROVE THE PLANS FOR THE GUAM PACIFIC ISLAND GOLD STAR MEMORIAL MONUMENT.

Per the Hagatña Restoration and Redevelopment Authority (HRRA), the monument is being completely financed by private funds and not government funds, thus HRRA does not anticipate any fiscal impact to its current Fiscal Year 2022 budget.
