*Hafa Adai!* Vice Speaker Tina Rose Muña Barnes:

The Bureau requests that Bill No. 203-36 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 203-36 is an act to add a new § 77136 to Chapter 77, Title 10 of the Guam Code Annotated, authorizing the Chief of Police each year to establish a budget plan for Executive Security for the following fiscal year. The provision further establishes a reporting requirement for the Chief of Police to submit to *I Maga'hågan Guåhan* and *I Liheslaturan Guåhan*, no more than ten (10) days from the close of each quarter, an update on the expenses associated with Executive Security.

As the Bill is administrative in nature, it poses no fiscal impact upon any funds of the Government of Guam as the projected expenses associated with Executive Security are already included within the annual budget for the Guam Police Department.
