The Bureau requests that Bill No. 221-36 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill 221-36 (LS) is an Act to add new §6104 and §6105, all of Article 1 of Chapter 6, Title 4 Guam Code Annotated, relative to the public disclosure of quarterly staffing patterns and personnel information reports increasing transparency and improved data articulation for fiscal accountability and planning.

The proposed legislation would require all Government of Guam departments/agencies to post agency staffing patterns on their website on a quarterly basis. Further, departments/agencies would be required to post personnel information reports on their website on a monthly basis.

As such, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
