The Bureau requests that Bill No. 48-36 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 48-36 is seeking to amend §58110(d) of Chapter 58, Title 12, Guam Code Annotated, relative to the expansion of the Public Investments options for qualifying certificates holders to include programs and projects sponsored or proposed by a village's Mayor and/or Municipal Planning Council. Per the Guam Economic Development Authority, currently the Public Investments and Community Contribution monies can be used for municipal programs and projects. Thus, the proposed language is unnecessary. It also notes, should the recently introduced Bill 42-36 be passed it will dedicate virtually the entire funding source for the Qualifying Certificate Community Contributions grant programs, which will in essence terminate the program.

The proposed amendment is administrative in nature and would not fiscally impact the appropriations for FY 2021.
