Hafa Adai! Vice Speaker Muña Barnes:

The Bureau requests that Bill No. 45-36 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 45-36 is seeking to address mandatory minimum sentences for repeat sexual offenders by including criminal sexual conduct convictions from other jurisdictions when considering enhanced sentences for repeat offenders. The Bill further amends the statute for repeat sex offenders to spend a minimum of 25 years in prison for 1st-degree criminal sexual conduct, 15 years for 2nd-degree criminal sexual conduct and 10 years for 3rd-degree criminal sexual conduct before they are eligible for parole.

The proposed amendments are administrative in nature and would not fiscally impact the appropriations for FY 2021.
