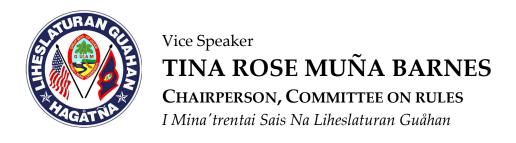

1/ Bill 30-36 (COR) proposes to prohibit the cost of Executive Security to be funded from the Guam Police Department's (GPD) appropriations but rather by the Governor and Lieutenant Governor's annual budget appropriations for the purchase and/or lease of vehicles, personnel costs, overtime or any resources used by the Executive Security. The GPD provided costs incurred in FY2019 which totalled approximately \$1.72M. It should also be noted, in a the fiscal note for Bill 190-35 (COR), it was stated that the Administration has noted the prioritizing of public safety and needs of GPD to include paying back years of overtime due to officers and hiring and training of additional police officers. Executive Security has been performing its duties within its means and with the minimal overtime coverage. The Administration does not provide for spousal protection and the use of police escorts for off-island security is only at the insistence of the Executive Security personnel. The FY2021 Budget Act did not appropriate any funds in either the Governor or Lieutenant Governor's budgets for this purpose. It should also be noted that the Governor and Lt. Governor's levels in the FY2022 Executitive Budget Request does not provide funding for the aforementioned services.
