

Hafa Adai! Vice Speaker Tina Rose Muña Barnes:

The Bureau requests that Bill No. 64-36 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 64-36 is an act to add a new Chapter 15 to Division 1, Title 5 of the Guam Code Annotated (GCA) to be known as the "Bureaucracy Simplicity Act of 2021." The intent of the legislation is for the elimination of unnecessary or unenforceable regulations from Government of Guam agencies which are defined pursuant to Chapter 3 of Title 5 GCA and Title 12 GCA, and limiting to those regulations demonstrably necessary to fulfill legitimate public health, safety, and welfare objectives. The agencies will be mandated within one (1) year of the Bill's enactment to conduct a comprehensive review of all occupational and business regulations and license procedures within their jurisdictions.

As the Bill is administrative in nature, it poses no fiscal impact upon any funds of the Government of Guam.
