The Bureau requests that Bill No. 62-36 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 62-36 (LS) is an act to amend §§ 43.10(d) and 43.70, both of Chapter 43, Title 9, Guam Code Annotated, relative to penalties and restitution for theft of livestock or agricultural products. The proposed legislation includes agricultural products in the definition of property under the Theft and Related Offenses chapter of Guam Code Annotated. Further, the proposed legislation includes agricultural products as eligible properties for reimbursement to the owner if the defendant is found guilty of stolen property.

The proposed legislation states that the defendant found guilty of stolen agricultural products shall reimburse the owner of the property its fair market value or through Alternative Community Service.

As such, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
