The Bureau requests that Bill No. 108-36 (COR) be granted a waiver pursuant to Public Law 12-229, as amended for the following reason(s):

Bill No. 108-36 (COR) is "AN ACT TO AMEND §1302, §1308, AND §1310(b)(1)(A) OF ARTICLE 3, CHAPTER 1, TITLE 26, GUAM ADMINISTRATIVE RULES AND REGULATIONS, RELATIVE TO STREAMLINING ADOPTION POLICIES AND PROCEDURES IN GUAM."

In an effort to streamline the adoption procedure and policies on Guam, the proposed legislation includes amendments that will allow for a child who is legally free for adoption to be placed in the care of a duly registered adoption agency and for the child to remain under the guidance and supervision of the adoption agency for up to one (1) year. Further, the proposed bill stipulates that priority will be given to current foster parents, if applicable. Lastly, an infant relinquished under the Safe Haven Act will not require a meeting under the Adoption Screening Committee (ASC).

As such, the bill is administrative in nature and poses no fiscal impact upon any of the funds of Government of Guam.
