The Bureau requests that Bill No. 125-36 (COR) be granted a waiver pursuant to Public Law 12-229, as amended for the following reason(s):

Bill No. 125-36 (COR) is an act to amend § 403 (l) of Chapter 4, Title 1, Guam Code Annotated, relative to changing the official name of the Municipality of "Santa Rita" to its name in the Chamoru language, namely "Sânta Rita". Per the proposed legislation, all references to Santa Rita in the Guam Code Annotated and the laws, rules, and regulations shall be understood to refer to Sânta Rita.

As such, the bill is administrative in nature and poses no fiscal impact upon any of the funds of Government of Guam.
