

## Bureau of Budget & Management Research Comments on Bill No. <u>112-36 (COR)</u>

Bill No. 112-36 seeks to amend the current Medical Malpractice laws on Guam by repealing Chapter 10 of Division 1, Title 10, Guam Code Annotated (GCA) relative to the Medical Malpractice Mandatory Arbitration and replacing it with the Medical Malpractice Pre-Trial Screening Act. Current law requires that any medical malpractice claim that accrues or is being pursued in the territory of Guam shall be submitted to mandatory arbitration before filing in court.

The Bill adds a new chapter 10 to Division 1, Title 10, GCA, referred to as the Medical Malpractice Pre-Trial Screening Act, whereas any claim for damages for personal injury or death on account of alleged medical malpractice of a healthcare provider shall be submitted (sealed) from either the Superior Court of Guam or the District Court of Guam to medical malpractice pre-trial screening by a Magistrate Judge. The Bill further includes the following:

- Upon the rendering of the judge's opinion, either party may pursue their right to a jury trial within 30 days.
- Parties may agree upon mutual consent to make a motion to the Magistrate Judge to hold proceedings in abeyance, while they submit their dispute pursuant to the provisions of either the Guam International Arbitration Law or Guam's Mediation Statute.
- Claims against defendants for \$20,000 or less may be exempted from the legislation if filed with the Small Claims Division upon mutual consent of the parties.
- Claims against the government of Guam and its agencies are governed by the Government Claims Act and are not subject to the Bill.

The intent of the Bill is to relieve the upfront costs of arbitration for residents seeking medical malpractice claims. However, with no substantive information regarding the litigation, procedural, and judicial costs of medical practice claims on Guam, the fiscal impact of this legislation cannot be determined at this time. Furthermore, as stipulated by the Bill, claims against the Government of Guam and its agencies are governed by the Government Claims Act and are not subject to this proposed legislation.
