## Bureau of Budget & Management Research Comments on Bill No. <u>135-36 (COR)</u>

The intent of Bill No. 135-36 is to revise existing pet licensing and registration laws by amending Article 1, Chapter 34, Title 10 Guam Code Annotated (GCA). The first amendment is to § 34102 which requires all pet owners to register their pets with the Department of Agriculture (DOAg) and have them implanted with a pet identifier microchip which shall be registered with a pet registry or controlled database.

With DOAg already tasked with the registration of pets, the fiscal impact of this amendment would be the implementation, training, and maintenance of the database if the department does not currently utilize one. However, absent additional information such as the unspecified costs of the software and training necessary to operate this database, a more accurate fiscal impact of this amendment cannot be determined at this time.

The Bill also amends § 34116 (b), which raises the apprehension, impoundment, & disposal age of any pet from 3 months to 6 months and § 34116 (c), whereas pet owners may be notified digitally, via the Department's website or via email of pet impoundment.

The Bill further adds a new § 34116 (h) establishing the Intact Pet Entry Fee, not to exceed \$120, for all pets entering Guam that are not sterilized. This new section dictates that all funds collected from this fee be deposited into the Stray Dog Revolving Fund, pursuant to § 34123 of this Chapter. However, § 34307, which created the Rabies Prevention Fund (RPF), states that all monies collected under the provisions of this Chapter (34), shall be deposited in the RPF at the current fee of \$60 per entry permit. As such, any funds collected from the Intact Pet Entry Fee should be deposited into the Rabies Prevention Fund.

An additional amendment in the Bill effects Article 1, Chapter 3, Title 9, Guam Administrative Rules and Regulations (G.A.A.R.) by amending §§ 3106 (e) and (f) by increasing the annual license fee for pets from \$5 to \$20 and increasing the penalty per month for late renewals of licenses from \$1 to \$15, respectively.

Overall, the fiscal impact of Bill No. 135-36 will be to the revenues generated by the increases in pet licensing fees and entry permits which make up the Rabies Prevention Fund. The attached table (See Table 1) was generated from information obtained from AS400 showing the total revenues collected from the pet licensing fees and the entry permits from FY18 through FY20 and the average of those revenues. It further projects the estimated collection revenues with the proposed adjusted fees and the potential variance in overall collections should Bill No. 135-36 be implemented. Table 1.
