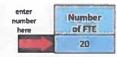

Comments

1/ The proposed legislation intends to mandate the Guam Customs and Quarantine Agency (CQA) to conduct customs officer training cycles annually for no more than twenty (20) candidates per fiscal year and would provide the agency director the opportunity to request for funding for the recruitment and training cycle as part of the CQA's proposed annual budget each fiscal year. Per the CQA, the total cost impact for a single training cycle each fiscal year is estimated at \$1,048,200. Reference the attached training cycle cost breakdown and Guam Community College Criminal Justice Certificate cost breakdown provided by the CQA for additional information. It should be noted that provisions of this Bill may adversely affect the Governor's ability to provide financial resources to other public safety entities and/or other key service areas including health and education.
