The Bureau requests that Bill No. 146-36 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 146-36 is an act to create a new Chapter 25 of Title 1 of the Guam Code Annotated (GCA) to establish a Guam Criminal Law and Procedure Review Commission. The Bill identifies the composition of the commission and its functions to review the current provisions that address the criminal laws and procedures of Guam and to make recommendations of enactments, amendments, and repeals to I Liheslaturan Guahan for action. Members of the commission will not be entitled to compensation or reimbursement of expenses, and the administrative function and support for the commission will be equally shared by its appointing authorities. Furthermore, the Bill states that one (1) year upon enactment or when the commission completes its mandates, whichever comes sooner, the commission shall be abolished and the Act under Chapter 25 of Title 1 GCA shall expire.

As the Bill is administrative in nature, it poses no fiscal impact upon any funds of the Government of Guam.
