*Hafa Adai!* Vice Speaker Tina Rose Muña Barnes:

The Bureau requests that Bill No. 180-36 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 180-36 is an act to amend § 19404 of Chapter 19, Title 10 of the Guam Code Annotated (GCA). The Amendment adds that any order from the Governor which establishes citations or fines for those who violate a Governor's Executive Order pursuant to Chapter 19, Title 10 GCA, or any order from the Governor which mandates the requirement of vaccinations for government employees, private businesses, and their patrons, also pursuant to this Chapter, shall be approved by the Guam Legislature by a majority vote.

As the Bill is administrative in nature, it poses no fiscal impact upon any funds of the Government of Guam.
