Hafa adai, Vice Speaker Muña Barnes:

The Bureau requests that Bill No. 336-36(COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 336-36 (COR): An act to approve the lease of Lot 2, Block 2, Tract 1143 in the municipality of *Dededo*, Guam, between the Government of Guam and the Kosraean Association of Guam

The proposed legislation intends to approve the lease of Lot 2, Block 2, Tract 1143 in *Dededo*, between the Kosraean Association of Guam – a non-profit organization (NPO) – and the Department of Land Management (DLM). Per this bill and in Guam Public Law 22-18, twenty (20) acres of land in *Dededo* or *Hagat* was reserved for cultural centers, with adequate space still available. These NPO's must have good standing with the Department of Revenue & Taxation, and must perfect their claim and/or application for the land lease. Note, there is no indication of rental costs. Per Public Law 25-47, the lease needs to be reviewed and approved by *I Liheslaturan Guahan*.

As such, the proposed legislation administrative in nature and poses no fiscal impact on the Government of Guam.
