Hafa adai, Vice Speaker Muña Barnes:

The Bureau requests that Bill No. 338-36(COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 338-36 (COR): An act to approve the lease of Tract 1143, Block 3, Lot 10, in the municipality of *Dededo*, Guam, between the Government of Guam and the Chuukese Association of Guam

The proposed legislation intends to approve the lease of Lot 10, Block 3, Tract 1143 in Dededo, Guam between the Chuukese Association of Guam – a non-profit organization (NPO) – and the Department of Land Management (DLM). Per this bill and in Guam Public Law 22-18, twenty (20) acres of land in Dededo or Hagat was reserved for cultural centers, with adequate space still available. These NPO's must have good standing with the Department of Revenue & Taxation, and must perfect their claim and/or application for the land lease. Note, there is no indication of rental costs. Per Public Law 25-47, the lease needs to be reviewed and approved by *I Liheslaturan Guahan*.

As such, the proposed legislation administrative in nature and poses no fiscal impact on the Government of Guam.
