Bureau of Budget and Management Research Comments on Bill No. <u>349-36 (LS)</u>

The proposed legislation seeks to repeal and reenact §7161 (a) and (e) all of Chapter 7, Title 16 Guam Code Annotated relative to updating the Streetlight Fund to authorize the Department of Public Works (DPW) to facilitate installation and maintenance of streetlights, road repair, and enhance safety of motorists, bicyclists, and pedestrians.

Currently, §7161 (a) establishes the Street Light Fund and that it be maintained separate and apart from any other funds, including the General Fund of the government of Guam. §7161 (a)(1) provides that money in the Street Light Fund be used to pay for the installation and operation of public street lights and §7161 (a) (2) provides that all revenues deposited in the Fund are reserved for use by the Guam Power Authority (GPA) for payment and operation and installation of public street lights. The Bill 349 intends to change the current law and create the Street Light Fund as a non-lapsing, revolving fund. It will continue to be separate and apart from other funds of the government of Guam. It will not be subject to any transfer authority of *I Maga 'hågan Guåhan*. However, the Director of DPW shall have programmatic oversight of the Street Light Fund. The Director of DPW shall submit a quarterly report to *I Liheslaturan Guåhan*. Bill 349 also authorizes additional expenditures of monies in the Street Light Fund to include the payment for improvements to lanes, sidewalks, bus shelters, or other projects deemed necessary by the Director of DPW to improve motor, bicycle, and pedestrian safety; and the payment for repairs or repaving of roads.

Additionally, §7161 (e) currently mandates that no funds from the Street Light Fund may be expended or encumbered without an appropriation by *I Liheslaturan Guåhan*. The Bill 349 will provide that all monies in the Street Light Fund to be appropriated and shall continue to be deemed appropriated to the DPW to be expended in accordance with § 7161 (a).

It should be noted that funds under the Street Light Funds are annually appropriated to the Department of Administration (DOA) to partially pay the GPA for the operation of public streetlights. The following table provides information as to Public Streetlight Appropriations:

According to comments received, the DPW notes the following questions and concerns with Bill 349 relative to the installation and maintenance of public street lights. Such as:

- 1) The transition period for DPW to ease the installation and maintenance process of Street Lights, Road Repair, and Enhance the Safety of Motorists, Bicyclists, and Pedestrians if Repealed and Reenacted.
- 2) Clarification of the installation and maintenance responsibilities between DPW and GPA. Does GPA continue to do the installation of street lights and maintain it? Or will DPW ease this process through the Bill by maintaining the street lights?

- 3) Manpower requirements for the additional responsibilities. As DPW is short in manpower, will additional funding from the General Fund be provided for additional FTEs, goods, and services for maintenance?
- 4) Shortfall of appropriations for public streetlights. How are appropriation shortfalls to be covered? The DPW indicated that the Street Light Fund had an estimated shortfall of \$76,000 in FY2022 which DPW was able to cover internally under funding to the Highway Maintenance division.
- 5) The GPA bills DPW for Street Lights. The average monthly bill per fiscal year: FY20 = \$323,393.21; FY21 = \$315,560.15; FY22 = \$337,941.67
- 6) The increase in fuel cost impact have impacted Street Light (SL) costs by 42% or \$79,838.08 between the August 2022 SL bill of \$366,848.31 and the September 2022 SL bill of \$446,686.39.
- 7) The Coronavirus Pandemic has increased costs for all good and services throughout the Nation and has impacted the cost of Village Street Road Repairs as follows:
 - FY2020 Village Street Road Repairs: 5,280 (linear footage) estimate cost of \$642,916.96 per mile
 - FY2021 Village Street Road Repairs: 5,280 (linear footage) estimate cost of \$730,542.80 per mile
 - FY2022 Village Street Road Repair Round 4 Cost: 79,219 linear footage (15 miles) \$10,488,824.91 or \$699,254.99 per mile

The Bureau notes that Bill 349 may negatively impact the appropriations to fund the installation and maintenance of public streetlights. The proposed addition of authorized expenditures of the Street Light Fund may lead to reduced funding from the Street Light Fund to cover the annual cost requirements of public streetlights. Should this occur, additional funding subsidies from the Guam Highway Fund or from the General Fund may be required to offset the reduction from the Street Light Fund. Additionally, it could cause DPW to absorb the shortfall of public streetlight expenses from its fiscal year operational budget appropriations.
