*Hafa Adai!* Vice Speaker Tina Rose Muña Barnes:

The Bureau requests that Bill No. 347-36 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 347-36 (LS) is "An act to approve the Hagåtña Restoration and Redevelopment Plan and its supporting documents."

Per the Hagåtña Restoration and Redevelopment Authority (HRRA), the Hagåtña Master Plan, Map Atlas, and Design Guidelines in the proposed subject bill have no fiscal impact. What would have a fiscal impact is the Implementation Plan, which is not part of the proposed bill. The Implementation Plan would identify prioritized actions that HRRA, Guam Economic Development Authority, and the Government of Guam can take to implement the Hagåtña Master Plan.

For the above reasons, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
