The Bureau requests that Bill No. 354-36 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 354-36 (COR) is "An act to add a new § 80129 to Chapter 80, Title 5, Guam Code Annotated relative to the acquisition of library books, e-books, audiobooks, digital publications, newsletters, software, and any other publications deemed necessary by the Guam Public Library System."

The proposed legislation intends to add language authorizing the Guam Public Library System to determine what publications are deemed necessary to meet the mandates and needs of the Public Library.
