The Bureau requests that Bill No. 254-36 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 254-36 (COR) is "An Act to Add a New Chapter to Division 2 of Title 17 Guam Code Annotated; relative to Defining the Educational and Professional Requirements for Certified School Counselors; and to Authorize the Compiler of Laws to make Changes."

The Bill intends to define and provide the qualifications for Certified School Counselors at the Department of Education. The Bill will also establish the scope of practice, the appropriate and inappropriate duties and activities, professional standards and competencies, and a code of ethics for Certified School Counselors. In addition, the Bill will establish a School Counselor Director/Coordinator for the school districts to provide support to the School Counselors.

Bill 254-36 is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
