Hafa Adai Vice Speaker Barnes:

The Bureau requests that Bill No. 318-36 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 318-36 (COR) is an Act to amend §12203 (a) of Article 2, Chapter 12, Title 10, Guam Code Annotated, relative to the composition of the Guam Board of Medical Examiners.

The proposed legislation makes changes to add recommendations as to appointments to the Board; reduces the number of physicians requirement; adds a condition that at least two (2) of the seven (7) members be appointed by the public; adds that after October 1, 2022, all newly appointed members shall serve a term of three (3) years; and changes the term of appointment to not more than two (2) consecutive full terms.

As such, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
