## Footnotes:

1/: In its current form, the subject legislation proposes to reduce the age for Category 1 and Category 2 Peace Officers who are members of the DB 1.75 retirement plan from 62 to 57, to retire early without facing penalties. As stated in the Bill, the recommended age of the federal government for most law enforcement and peace officer positions to mandatorily separate and retire is 57 and for federal firefighters, the age to retire is 55. The legislation would not amend the amount of the penalties for early retirement as DB 1.75 members would still have the option to retire at age 55. However, the Bill would end any penalties once the member turns the age of 57. There may be a potential cost savings to the Government of Guam with the retirement of senior Peace Officers and hiring of new Peace Officers at entry level salaries & benefits. Conversely, there would likely be an impact to the GGRF due to increased rate of retirement of qualified Officers. However, absent additional information from the Fund, the Bureau can not provided the overall fiscal impact of the Bill. It should be noted that the GGRF is conducting a mandated cost study on uniform personnel and their retirement benefits but this study will not be completed until the end of the month.
