The Bureau requests that Bill No. 309-36 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill 309-36 (LS) is an Act to amend §12212(g), Article 2, Chapter 12, Title 10, Guam Code Annotated, relative to ensuring persons or entities who have reported are promptly informed of Guam Board of Medical Examiners' actions and decisions.

The proposed legislation stipulates that the Guam Board of Medical Examiners promptly inform through phone call, letter, or email of the Board's actions, decisions and final disposition in the matters reported to the Board. The cost of requiring to inform via phone call, letter or email is part of the Board's operational costs and should not pose any additional fiscal impact to their operational budget.

As such, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
