Hafa Adai, Vice Speaker Barnes:

The Bureau requests that Bill No. 330-36 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 330-36 (COR) is an act to amend §3703 of Chapter 3, Title 22, Guam Code Annotated, relative to including students attending institutions of higher learning who are under the age of eighteen (18) in the provisions which allow parents to obtain leave for child school-related purposes.

Current law states that an employer shall not discharge or in any way discriminate against an employee who is a parent of one (1) or more children of the age to attend pre-school, kindergarten, or grades one (1) to twelve (12). The proposed bill wishes to include students attending an institution of higher learning who is under the age of eighteen (18). Current law also allows for the employee to use up to a maximum of four (4) hours every two (2) pay periods of administrative leave for child school-related activities, which may be utilized at the arrangement of the employee with the employee's supervisor, and may be split into smaller separate segments over the two (2) pay period time frame, but shall not carry over to the next two (2) pay periods or thereafter. Whereas, the proposed bill will allow up to eight (8) hours in any calendar month to attend the child's orientation and other related purposes at institutions of higher learning.

As such, the bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
