Dear Speaker Terlaje:

*Buenas Yan Saluda!* As per PL 35-36, Section 20, page 162, the following is the breakdown of Prior Year Obligations that the Guam Police Department (GPD) has paid out:

- Sergeant 1 Rock J.B. Anciano- On January 6, 2021, our office received an email from the Department of Administration regarding benefits that should have been paid by GPD on behalf of Sgt. 1 Anciano while on long term disability. Based on the DOA email, our office realized that Sgt. 1 Anciano was required to provide receipts reflecting his portion of payment so that GPD would make the appropriate payments. Unfortunately, this was not the case, and although payments were not made timely, GPD is still obligated to pay the prior year obligation of the government share totaling \$8,504.80 (FY2019-3,925.68 + FY2020-\$4,579.12)
