**RELATIVE TO ENDORSING THE NOMINATION OF MICHELLE
KRAMER FOR U.S. AMBASSADOR TO THE REPUBLIC OF THE
MARSHALL ISLANDS IN THE BIDEN-HARRIS ADMINISTRATION**
