**AN ACT TO *AMEND* § 1117; AND TO *ADD* A NEW § 1123
CHAPTER 1, TITLE 3, GUAM CODE
ANNOTATED, RELATIVE TO CHANGING A
PRECINCT TO A DISTRICT AND DEFINING
THE NAME OF A CANDIDATE OR NOMINEE.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 1117 of Chapter 1, Title 3 Guam Code Annotated is *amended*
3 to read as follows:

4 “§ 1117. **Same: ~~Precinct~~ District.**

5 Each district of Guam, as defined in Title 1 GCA § 403, shall constitute
6 a ~~precinct~~ voting district.”

7 **Section 2.** A new § 1123 is hereby *added* to Chapter 1, Title 3, Guam Code
8 Annotated to read as follows:

9 “§1123. **Name.**

10 In the case of a candidate or a nominee, the word ‘name’ shall mean the
11 name that appears on his/her United States Birth Certificate, United States
12 Passport, Certificate of Naturalization, Court Ordered Name Change,
13 Certificate of Marriage, or any identification meeting the REAL ID Act

1 requirements issued by a state. Anywhere in this Title the word ‘name’
2 appears, this definition shall apply.’

3 **Section 3. Effective Date.** This Act shall be effective immediately upon
4 enactment.

5 **Section 4. Severability.** If any provision of this Act or its application
6 to any person or circumstance is found to be invalid or contrary to law, such
7 invalidity shall not affect other provisions or applications of this Act which can be
8 given effect without the invalid provision or application, and to this end the
9 provisions of this Act are severable.
