AN ACT TO *AMEND* THE FISCAL YEAR 2024 ADOPTED TOTAL GENERAL FUND REVENUE FROM EIGHT HUNDRED TWENTY-EIGHT MILLION EIGHT HUNDRED SEVENTY-TWO THOUSAND ONE HUNDRED NINETY-NINE DOLLARS (\$828,872,199) TO EIGHT HUNDRED THIRTY-THREE MILLION NINE HUNDRED SEVENTY-TWO THOUSAND ONE HUNDRED NINETY-NINE DOLLARS (\$833,972,199); AND, TO *APPROPRIATE* FIVE MILLION DOLLARS (\$5,000,000) FROM THE GENERAL FUND TO THE DEPARTMENT OF PARKS AND RECREATION FOR THE PURPOSE OF DESIGNING AND CONSTRUCTING THE “*NÅFTAN MAÑAINA-TA SHRINE*”.

2 **Section 1. Amendment to Fiscal Year 2024 Adopted Total General**

12 **Section 2. Appropriation.** Five Million Dollars (\$5,000,000) is
13 appropriated from the General Fund to the Department of Parks and Recreation for
14 the design and construction of the *Nâftan Mañaina-ta Shrine*. This appropriation
15 shall remain available until fully expended.

Section 3. Effective Date. This Act shall be effective upon enactment.
