AN ACT TO ADD A NEW ARTICLE 3, CHAPTER 18, TITLE 1, GUAM CODE ANNOTATED, RELATIVE TO ADOPTING A STANDARDIZED TYPE-FACE FOR THE GOVERNMENT OF GUAM.

## BE IT ENACTED BY THE PEOPLE OF GUAM:

**Section 1.** Legislative Intent. The Government of Guam has an obligation to ensure that all members of the community can access and understand their documents, reports, and communications. This includes persons with disabilities such as those with cognitive or visual impairments. To make sure this happens, it is important for the Government of Guam to adopt accessible font types in all its official documents, reports, and communications.

According to the United States Center for Disease Control, 1in 4 persons living on Guam have a disability. Of that figure, 16% have either a cognitive or visual impairment. An accessible font type makes it easier for people who have difficulty seeing text on a page due to visual impairment or other disability-related issues. Additionally, fonts designed specifically for accessibility often have wider character spacing so they look less crowded which helps increase legibility even further. Using these kinds of fonts not only improves the ability of persons with disabilities in Guam to access and understand their documents, it also sends a

2	environment. This will ensure our disabled citizens are given the same access to

4	<b>Section 2.</b> A new Article 3 is hereby <i>added</i> to Chapter 18 of Title 1, Guam
5	Code Annotated, to read:

11	The government of Guam shall adopt a standardized typeface for use on all official
12	documents, reports, and communications generated after enactment of this Act. Each
13	entity shall utilize a Sans Serif font, with Arial, Calibri, and Seaford font as examples
14	that are in compliance with this Section."
15	Section 3. Severability. If any provision of this Act or its application to any
16	person or circumstance is found to be invalid or contrary to law, such invalidity shall
17	not affect other provisions or applications of this Act which can be given effect
18	without the invalid provision or application, and to this end the provisions of this
19	Act are severable.
20	Section 4. Effective Date. This Act shall be effective at the beginning of
21	the next calendar year following enactment.
