AN ACT TO APPROPRIATE FIVE MILLION DOLLARS (\$5,000,000) FROM THE FISCAL YEAR 2024 GENERAL FUND REVENUES COLLECTED IN EXCESS OF THE ADOPTED LEVELS ENUMERATED IN PUBLIC LAW 37-42, AS AMENDED, TO THE DEPARTMENT OF PARKS AND RECREATION FOR THE PURPOSE OF PURCHASING EQUIPMENT AND SUPPLIES FOR THE ENHANCEMENT, MAINTENANCE, REPAIRS OPERATIONS OF GUAM'S PARKS, RECREATIONAL **FACILITIES** AND **BEACHES UNDER** JURISDICTION IN ADDITION TO THE PURCHASE OF ESSENTIAL EQUIPMENT FOR THE PARK PATROL DIVISION.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. Legislative Findings and Intent. Guam's parks, recreational facilities and beaches are vital to the island's natural beauty, offering recreational spaces that are central to community life and tourism. Ongoing maintenance and
- 5 enhancements are necessary to preserve these spaces, which in turn support Guam's

- 1 tourism industry by attracting visitors which assist in driving economic growth.
- 2 Additionally, adequate resources for park patrols are essential for ensuring public
- 3 safety and maintaining order in these public areas. Investing in these efforts also
- 4 fosters community engagement and environmental stewardship which result in
- 5 strengthening our local bonds and promoting a sustainable use of Guam's natural
- 6 resources.

- The intent of this Act is to appropriate Five Million Dollars (\$5,000,000) from Fiscal Year 2024 General Fund revenues for the enhancement, maintenance, and repair of Guam's parks, recreational facilities and beaches, as well as for the purchase of essential equipment for the Park Patrol Division. This funding will improve the quality and safety of public spaces, support tourism, and foster community involvement in preserving Guam's natural and cultural assets. The Act aims to create lasting benefits for both residents and visitors by investing in the island's recreational infrastructure and promoting a secure and inviting environment.
- **Section 2. Appropriation.** Notwithstanding any other provision of law, the sum of Five Million Dollars (\$5,000,000) is hereby appropriated from the Fiscal Year 2024 General Fund revenues collected in excess of the adopted levels enumerated in Public Law 37-42, as amended, to the Department of Parks and Recreation for the purpose of purchasing equipment and supplies for the enhancement, maintenance, repairs and operation of Guam's parks, recreational facilities and beaches under its jurisdiction in addition to the purchase of essential equipment for the Park Patrol Division. This appropriation shall be available until fully expended. The funds allocated and authorized in this Section are not subject to *I Maga'hågan Guåhan's* transfer authority.
 - **Section 3. Effective Date.** This Act shall be effective upon enactment.
