AN ACT TO AMEND SUBSECTION (n)(7) OF SECTION 1, CHAPTER V, PUBLIC LAW 37-125, RELATIVE TO ALLOCATING FUNDS TO THE MAINTENANCE AND THE PROCUREMENT OF NECESSARY EQUIPMENT FOR THE DEPARTMENT OF CORRECTIONS' ADULT CORRECTION FACILITY (ACF) AND THE HAGATÑA DETENTION FACILITY (HDF).

## BE IT ENACTED BY THE PEOPLE OF GUAM.

Section 1. Legislative Intent. I Liheslaturan Guåhan finds that the 2 3 Department of Corrections (DOC) requires additional funding to address and remedy immediate safety concerns in two of its facilities, specifically the Adult Correction 4 5 Facility (ACF) and the Hagåtña Detention Facility (HDF). The ACF and the HDF 6 facilities are in dire need of maintenance, repair, and new security materials, vehicles, and equipment in order to ensure safety in these facilities. Public Law 37-7 8 125 provides DOC Five Million Dollars (\$5,000,000) for the construction of a new facility, but because DOC's existing facilities are in critical condition, it is more 9 10 important to prioritize the repairs and maintenance of the existing facilities while a 11 new facility is underway. By amending the agency's FY 2025 appropriation detailed 12 in Public Law 37-125 and allocating funds to maintenance, repairs, and the 13 procurement of equipment for their existing facilities, it will enable the DOC to

address the pressing issue of maintenance and repairs without having to receive appropriation from other government sources.

Therefore, it is the intent of *I Liheslaturan Guåhan* to amend Public Law 37-125 in order to allocate funds to address the dire need of maintenance, repairs, and acquisition of equipment of the existing facilities operated by DOC. This legislation will provide DOC the funding to address this issue without having to seek additional appropriation from another government source.

**Section 2.** Subsection (n)(7) of Section 1, Chapter V, Public Law 37-125 is hereby *amended* to read as follows:

"(7) Department of Corrections (DOC) Facilities Maintenance, Renovation, and Procurement of Security Equipment Appropriation and Modernization Act Appropriation. The sum of Five Million Dollars (\$5,000,000) is appropriated from the General Fund and shall be expended for the renovation, maintenance, and repairs of the DOC Adult Correction Facility (ACF) and Hagåtña Detention Facility (HDF), procurement of security system materials, property, vehicles, and equipment for ACF and HDF, and for the cost associated with the financing, design, construction, maintenance and related expenses of the new Department of Corrections facility as established by Public Law 36-57, the Department of Corrections Modernization Act of 2021."

**Section 3. Severability.** *If* any of the provisions of this Act or the application thereof to any person or circumstance is held invalid, such invalidity *shall not* affect any other provision or application of this Act which can be given effect without the invalid provision or application, and to this end the provisions of this Act are severable.

Section 4. Effective Date. This Act shall be effective upon enactment.
