### 1 BE IT RESOLVED I MINA'TRENTAI SIETTE NA LIHESLATURAN

2 GUÅHAN:

WHEREAS, on January 5, 2023, newly elected members of the Guam
Legislature adopted the Standing Rules for the 37th Guam Legislature; and

5 WHEREAS, on page 80 and 81 of these standing rules, it addresses Special 6 Investigating Committees and states: "Except as provided by these Rules, no 7 Committee for the investigation of any special subject shall be authorized, except 8 pursuant to a Legislative Resolution, which shall be approved by the affirmative vote 9 of a majority of the Members elected to *I Liheslaturan Guåhan*; and 1 WHEREAS, "the subject and purpose of the investigation shall be expressed 2 in the title of the Legislative Resolution, and the scope of the investigation shall be 3 consistent with the subject and purposes so expressed. No such Committee shall 4 have authority to extend its investigations to subjects not so expressed, nor beyond 5 the scope indicated in the Legislative Resolution"; and

6 WHEREAS, on March 21, 2023, during an Emergency Session, Republican
7 Caucus leader, Frank Blas, Jr., was sent an image on WhatsApp of a circulating floor
8 amendment purporting to be official document; and

9 WHEREAS, this document had the initials "CMD" indicating that it was
10 submitted by Senator Christopher M. Dueñas (see attachment); and

WHEREAS, Senator Christopher M. Dueñas did not propose or submit such an amendment to Bill No. 32-37 (COR). This amendment was not uploaded to the Session Drive folder controlled by the Committee on Rules and was not circulated in print on the session floor; and

WHEREAS, this fraudulent document was forwarded numerous times and
shared on multiple social media pages owned by Progressive Democrats of Guam
(PDG); and

18 WHEREAS, the page owner of PDG and has intentionally shared this 19 document far and wide; and

WHEREAS, the page owner of PDG has stated to local news outlets that he
received this fraudulent "official" document from the Guam Legislature; and

WHEREAS, these accusations should be addressed publicly via the Guam Legislature's live streamed television channel and online platforms owned by the Guam Legislature to clear the name of those affected by the circulation of this fraudulent document; and

WHEREAS, Senator Christopher M. Dueñas stated on session floor *for the record* that he did not propose this amendment and that those who are sharing it as well as posting it online are circulating a lie; and

1 WHEREAS, the Standing Rules of the 37th Guam Legislature allows for the creation of a Special Investigating Committee; and 2

WHEREAS, it is the duty and responsibility of all members of the 37th Guam 3 Legislature to hold any and everyone associated and responsible for the creation and 4 5 dissemination of fraudulent documents accountable; and

WHEREAS, this Special Investigating Committee shall have subpoena powers from either the Committee Chairperson OR Vice-Chairperson for the 7 8 purposes of fair and transparent government; now therefore, be it

9 **RESOLVED**, that *I Mina'trentai Siette Na Liheslaturan Guåhan* does hereby, on behalf of the people of Guam, create a Special Investigating Committee 10 11 consisting of three (3) members of the majority and two (2) members of the minority of I Mina'trentai Siette Na Liheslaturan Guåhan, and for the leadership of the 12 13 Special Investigating Committee to be voted on by the Body; and

**RESOLVED**, to further investigate the actions of Progressive Democrats of 14 Guam, their social media pages and messaging, and those associated with their 15 16 organization and/or dissemination of this fraudulent document; and be it further

17 **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of the same be thereafter transmitted to all 18 19 senatorial offices of the 37th Guam Legislature; and to the Honorable Lourdes A. Leon Guerrero, I Maga'hågan Guåhan. 20
