WHEREAS, San Isidro, translated from "Saint Isidore," was born in Madrid, Spain, in the latter half of the twelfth (12th) century, and lived a simple life with his parents. He married at a young age to Maria Torribia, also known as Maria de la Cabeza, who after passing was canonized into sainthood by the Catholic Church. During his life he worked as a humble farmer, tilling fields and devoting himself to God, often spending his days praying, attending church, and serving the less fortunate; and

WHEREAS, San Isidro died on May 15, 1120, at the age of sixty (60), and the Catholic Church canonized him as a Saint on March 12, 1622; and

WHEREAS, the San Isidro Chapel in Malojloj became a reality in 1948 through a donation of land from local resident, Joseph Meno and was officially declared San Isidro Parish on July 21, 1973, remaining a symbol of unity and hard work to the community of Malojloj; and

WHEREAS, since 1973, the community of Malojloj has celebrated the feast day of San Isidro, the Patron Saint of the farmer; and this year marks the celebration of the Golden [Fiftieth (50th)] Jubilee Year Anniversary of San Isidro Parish; and

WHEREAS, the people of Malojloj, a farming community since the 1930s, believe that through the intercession of San Isidro they have received blessings of a rich harvest and an abundance of food to feast on; and

WHEREAS, in the wake of Typhoon Mawar which made landfall on Guam on May 24, 2023, the community of Malojloj and parishioners of San Isidro Catholic Church have continued to persevere through the island's recovery and remained diligent in their service to their community and their Patron Saint, San Isidro as they have done numerous times before; now therefore, be it
