3           **WHEREAS**, the Society of Human Resource Management National (SHRM)  
4 declared September 26th as SHRM Day to coincide with HR Professionals Day and  
5 SHRM Guam Chapter declared the whole week (9/25 - 9/29) HR Professionals Week;

8 Resources professionals as the backbone of the workplace. It brings to the forefront the  
9 importance and value of talent acquisition, management, and training to every  
10 organization; and

11           **WHEREAS**, for seventy-five (75) years, SHRM and HR have driven some of

13 create better workplaces where employers and employees thrive together. As the voice  
14 of all things work, workers and the workplace, SHRM is the foremost expert, convener
