3        **WHEREAS**, the Judiciary of Guam, as an integral part of the government,  
4 upholds the principles enshrined in the Constitution of the United States and the Organic  
5 Act of Guam, ensuring justice, equality, and the rule of law for all its citizens; and

6        **WHEREAS**, Constitution Day, celebrated annually on September 17th,  
7 commemorates the signing of the U.S. Constitution in 1787, a document that forms the  
8 foundation of our nation's laws and governance; and

9        **WHEREAS**, Constitution Week, observed from September 17th to September  
10 23rd, provides an opportunity for citizens to reflect upon the enduring principles of  
11 liberty, democracy, and justice, and to celebrate the rights and freedoms guaranteed by  
12 the Constitution; and

13        **WHEREAS**, the Judiciary of Guam is committed to upholding these  
14 constitutional principles, ensuring the fair and impartial administration of justice, and  
15 protecting the rights of all individuals within its jurisdiction; and

1           **WHEREAS**, the celebration of Constitution Day and Constitution Week serves  
2 to educate the public about the significance of the Constitution, to promote civic  
3 engagement, and to encourage an appreciation for the democratic processes that govern  
4 our society; and

5           **WHEREAS**, it is fitting and proper to recognize and honor the Judiciary of Guam  
6 for its unwavering dedication to the rule of law and the protection of constitutional  
7 rights on this significant occasion; and

8           **WHEREAS**, that the *Liheslaturan Guåhan* encourages all citizens of Guam to  
9 deepen their understanding of the Constitution, and to reaffirm their commitment to the  
10 values and principles it represents; now, therefore, be it

11           **RESOLVED**, that *I Mina'trentai Siette Na Liheslaturan Guåhan* does hereby,  
12 on behalf of the people of Guam, recognizes the Judiciary of Guam on the occasion of  
13 the 2024 “*Constitution Day*,” and “*Constitution Week*,” expressing profound gratitude
